ERRATA NOTICE

(Issued June 26, 2009)

On June 22, 2009, the Commission issued an Order establishing rates for electric and gas service for Central Hudson Gas & Electric Corporation (Central Hudson). While the Order approved an employee count of 840 to be included in the Labor Expense used to calculate the revenue requirement, inadvertently, this employee count was not used to calculate the final Labor Expense shown in the original electric Schedule 1 (\$45,558,000) and Gas Schedule 1 (\$10,860,000). The corrected Labor Expense for the electric case, as shown in the revised Electric Schedule 1, is \$46,245,000. In the gas case, the correct amount of \$11,024,000 is now shown in the revised Gas

Schedule 1. These corrected amounts lead to changes in several other expenses, including payroll taxes, productivity and working capital, as shown in revised Electric and Gas Schedules 1, 2, 3, 5, 7, 9, 10, 11, and 12.

Additionally, there was an error in the translation of the final electric sales forecast into service class revenues. When the sales forecast decided by the Commission was calculated errors were made when computing the associated change in billing kW, as well as an incorrect allocation of the sales to the individual service classifications. The correction of these errors results in a decrease in rate year revenues before the rate increase of approximately \$840,000, which results in an electric rate increase by the same amount; the gas case is unaffected. Therefore, the correct revenue requirement increase for electric service is \$39,597,000, not \$38,011,000, and for gas service the correct revenue requirement is \$13,828,000, not \$13,646,000.

Also, the corresponding corrections need to be made in the body of the order: at page 5, lines 16-17, delete "\$38.0" and "\$13.6" and replace with "\$39.6" and "\$13.8".
