Current Overview:

This continues to be an active weather event across the state. Road conditions are slow and treacherous in most areas. The forecast remains the same. The heavy wet snow is starting to taper of this morning across Western NY and is expected to slow this afternoon across the Companies' central and eastern service areas. Winds continued to increase through the morning and are expected to last through the afternoon hours and into Saturday, with the highest gusts in the Hudson Valley through Saturday afternoon. Non-hazardous weather is expected to return Sunday.





Crews and field personnel are engaged in make safe activities, responding to downed wires reports and assessing damage as weather conditions permit. The majority of damage identified to date are tree related and wires down. In the majority of our areas, damage is still occurring as weather system hangs over the state.

In Fillmore, 1 transmission issue has been restored. The second issue is currently being worked on. This impacts the majority of the Fillmore customers.

In Lancaster, we are actively working with National Grid on a transmission outage impacting 2500 customers.

Dry Ice/Bottled Water:

We are in the process of acquiring dry ice and bottled water, if needed, for distribution during this event.

Current Overview:
