#### NOTICE UNDER PSL §122(2)(c) February 24, 2016

## TO ALL LANDOWNERS OF LAND ON WHICH ANY PORTION OF THE FACILITY PROPOSED IN PSC CASE 15-T-0305 IS TO BE LOCATED:

Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid") filed an application on May 29, 2015 (supplemented on November 13, 2015) with the New York Public Service Commission ("Commission") pursuant to Public Service Law ("PSL") Article VII proposing the relocation and selective reconductoring and reconstruction of two of National Grid's existing 115 kilovolt ("kV") electric transmission lines, which are part of its electric transmission system, and the construction of a new substation, all located in Onondaga County, New York ("Project"). The Commission proceeding reviewing the Project is Case 15-T-0305.

The two transmission lines are proposed to be located on rights-of-way ("ROWs") running in a generally southerly direction from National Grid's Clay substation, located in the Town of Clay, to the National Grid's Teall substation, located in the Town of Salina, and passing through the Towns of Cicero and DeWitt. The new substation is proposed to be located on property in the Town of Cicero adjacent to the transmission corridor and approximately 0.28 miles north of the intersection of Route 11 and Route 31.

Most of the Project is proposed to be located, when completed, within the existing ROWs. At certain locations, however, the Project as proposed would require the acquisition of additional property to widen the ROWs or to site the proposed substation, as described in the application. In addition, as described in the application, the transmission structures proposed by National Grid, when rebuilt, would be taller than the structures they are to replace.

Your property may be impacted by this project.

Interested persons who wish to participate as parties in this case may file for party status. This may be done through the Commission's web site. From the home page of the Commission's web site (<a href="http://www.dps.ny.gov">http://www.dps.ny.gov</a>), a prospective party should click on "Search." On the Search page, the "Search by Case Number" box should be filled in with the number for this case (15-T-0305). This will bring the user to the main Document and Matter Management ("DMM") page for this case. On that page, the prospective party should click the button at the upper right labeled "Request for Party Status" to see a web page with instructions for the procedures to follow to become a party. The timeframe for filing an application to be a party to this case is throughout the pendency of the case.

#### Ways to Comment:

Via the Internet or Mail: The public may submit comments by email to the Hon. Kathleen H. Comments may also be entered directly into the case file for this matter by clicking on the button at the upper right labeled "Post Comments" on the main DMM page for this case (see above).

Toll-Free Opinion Line: Individuals may choose to submit comments by calling the Commission's Opinion Line at 1-800-335-2120. This line is set up to receive in-state calls 24 hours a day. These calls are not transcribed but a summary is provided to the Administrative Law Judge who will report to the Commission.

All comments should refer to "Case 15-T-0305." All comments will become part of the record considered by the Commission. Comments will be accepted throughout the pendency of this case. Also on the main DMM page for this case (see above), one can click on the "Public Comments" tab to read written comments, and on the "Filed Documents" tab to see other documents such as the application and transcripts of public statement hearings. An electronic copy of the application also is available on a CD-ROM for review in the public library in each of the following localities: DeWitt, Mattydale, Cicero, North Syracuse and Brewerton.

Many libraries offer free internet service, which can be used to obtain access to the Commission's website, including the DMM.
