AGREEMENT CHANGE ORDER NO. 1

THIS AGREEMENT CHANGE NO. 1 made and entered into effective this 1st day of April in the year 2013 by and between **National Grid USA Service Company, Inc.**, on behalf of its affiliate companies, including **Massachusetts Electric Company, New England Power Company, Nantucket Electric Company**, as corporations organized and existing under the laws of the Commonwealth of Massachusetts, with its principal place of business at 40 Sylvan Road, Waltham, MA, 02451; **National Grid Electric Services, LLC**, a corporation organized and existing under the laws of the State of New York, with its principal place of business at 175 East Old Country Road, Hicksville, New York 11801; **The Narragansett Electric Company**, a corporation organized and existing under the laws of the State of Rhode Island, 280 Melrose Street, Providence, Rhode Island 02901; **Niagara Mohawk Power Corporation**, a corporation organized and existing under the laws of the State of New York, with its principal place of business at 300 Erie Boulevard West, Syracuse, New York 13202 ("Owner"), and **NORTHERN CLEARING INCORPORATED Y.** ("Contractor"), having its office and principal place of business at ~~2328 ROUTE 9N, PO Box 656, Ausable Chasmt, NY 12912.~~ SDS 7/30/13

WHEREAS, the parties agree to amend the terms and conditions of the Agreement previously entered into by the parties on January 9, 2012 and,

WHEREAS, the Contractor has provided Owner with services upon request in accordance with the Purchase Order and Owner has elected to accept conditions for those services effective as of the date of this Purchase Order Change No. 1.

NOW, THEREFORE, in consideration of the terms and conditions previously agreed to and additional considerations incorporated herein, the parties agree that the Purchase Order shall be amended as follows:

1. **ARTICLE 1 – SCOPE OF WORK**

The Contractor hereby agrees that there are no changes to the original Scope. Owner clarifies that the Contractor could be called to work on Long Island, however any such work would be, at this time, under de-energized conditions. Additionally, due to Owner's divestiture of Granite State Electric, reference to work for this company is deleted.

2. **ARTICLE 3 – TERM AND SCHEDULE**

This Change №. 1 modifies original Agreement Paragraph 3.1 by extending the term one year through December 31, 2015.

3. **ARTICLE 4 – CONTRACT PRICE**

Unit prices and labor and equipment rates are modified for application to work performed after the effective Date April 1, 2015

4. **ARTICLE 5 – PAYMENTS**
