AGREEMENT

This Agreement, made and entered into on the date when signed by the party signing last in time ("Effective Date"), by and between **National Grid USA Service Company, Inc.**, a corporation organized and existing under the laws of the Commonwealth of Massachusetts, with its principal place of business at 40 Sylvan Road, Waltham, Massachusetts 02451 ("Owner"), and **Syracuse Utilities Inc.** ("Contractor"), a New York corporation, with its principal place of business at 9583 Brewerton Road, Brewerton, New York 13029 (hereinafter each, individually, a "Party" and, collectively, the "Parties") for the Services identified hereafter as:

ARTICLE 1 - SCOPE OF WORK

- 1.1 The Contractor hereby agrees to provide in accordance with National Grid standards all labor, materials, equipment, accessories, and services necessary perform the Queensbury Ductbank Project in Queensbury, NY, in accordance with all of the specifications and Contract Documents associated with this Agreement.
- 1.2 The Contractor hereby agrees to perform the following Work under this Agreement, in accordance with the specifications provided in the RFP as identified in Article 2.
- 1.3 No other work shall proceed without authorization. Additional Work may be identified by Owner for which Contractor shall submit a proposal. Owner, at its sole discretion may authorize Contractor to perform said Work. All work shall be authorized only upon complete execution of a Work Authorization Form (WAF) or Field Change Form (samples included in Schedule C). Contractor shall commence performance of authorized Work immediately and in accordance with this agreement unless otherwise mutually agreed and documented.

ARTICLE 2 - CONTRACT DOCUMENTS

2.1 The following documents, including all attached schedules, appendices, exhibits or other attachments thereto, are incorporated by reference as if fully set forth herein, and are hereinafter referred to collectively and individually as the "Contract Documents" or the "Agreement" listed in order of precedence:

In the event of conflict between the Contract Documents, the order of precedence shall be as set forth above.

2.2 Contractor acknowledges and agrees that corporate information and query responses entered by the Contactor into the www.ISNetworld.com application as a condition of the bid referenced in paragraph 2.2 are by reference made part of this Agreement.

ARTICLE 3 – TERM

3.1 The term of this Agreement shall commence on the Effective Date and continue in full force until all work listed in Schedule B has been completed and signed-off by Owner ("Term") unless terminated earlier in accordance with this Agreement.

ARTICLE 4 – SCHEDULE

- 4.1 Any supplemental Work, extra Work, or changed Work shall be conducted in accordance with a schedule to be developed in association with a Work Authorization Form or Field Change Form (Schedule C).
- 4.2 The Contractor shall perform the Work in accordance with the schedule. Once commenced, the Work shall be prosecuted continuously to completion unless otherwise agreed to by the Company.
- 4.3 The Contractor shall maintain a labor force of sufficient size and competence to conform to and complete all Work on schedule and within the scheduled hours and days set forth in the schedule unless otherwise directed or approved by the Company.
- 4.4 Time is of the essence as to performance by the Contractor of its obligations under the Agreement. If, at any time during the term of the Agreement, except for delays occurring pursuant to Terms and Conditions for Contractor Purchase Orders Article 6 Force Majeure, in the opinion of the Company the Contractor does not meet the schedule, the Company may for each incident of delay, at no additional cost to the Company, at is sole option:
 - (a) Require the Contractor to get back on schedule by working additional shifts and/or additional days and/or increasing its manpower, supervision, tools, and/or equipment.

and/or

(b) Treat such failure as a material breach and repudiate and terminate the Agreement and recover damages in accordance with Terms and Conditions for Contractor Purchase Orders Article 14.0 Termination.

ARTICLE 5 - CONTRACT PRICE

- This is a Firm Fixed Price (Lump Sum) Contract with a value determined by the Contractors' revised submittal dated June 17, 2015. The estimated value of this Agreement is although this value is neither firm nor guaranteed. The estimated value is based on the units of measure, estimated quantities and lump sum prices quoted.
- 5.2 The contract price of this Agreement shall be the total price to be paid by the Owner to the Contractor in accordance with the prices set forth in Schedule D and as specified in the relevant Work Authorization Form ("Contract Price").
- 5.3 Work shall be paid based on actual and verifiable labor and equipment costs as set forth in the Work Authorization Forms.
- 5.4 The Contractor shall, on a daily basis, furnish the Owner with daily work reports (in a format acceptable to the Owner) which briefly describe the Work rendered during the preceding day. Reports are to reflect the progress and description and number of any units completed. All quantities shall be verified by signature of the Owner's Field Representative. A duplicate of the original signed daily work report and receipts and invoices for Contractor-furnished materials, rented equipment and Subcontractors shall accompany all invoices which the Contractor shall present for payment.
- 5.5 The Contract Price shall be all-inclusive for the Work.
- The Contractor is responsible for all applicable taxes associated with the work scope. Taxes are not applicable to labor. No sums in addition to the original contract amount will be paid by the Owner for taxes, fees, permits, or other levies which may be imposed on the world by any authority having jurisdiction over the work of services to be provided and or performed by the Contractor.

ARTICLE 6 - PAYMENTS

- 6.1 For all sums payable to the Contractor, as described in Article 5, National Grid will pay Contractor within thirty (30) days from receipt of a complete and acceptable invoice. Any allowable time for early payment discount shall begin the day the invoice is received at National Grid. The invoice date will not be used to calculate the allotted time available to exercise the specified payment discount. Unacceptable invoices may, at National Grid's option, be adjusted and paid as adjusted or returned to the Contractor for correction and re-submittal.
- 6.2 Invoices shall be submitted and payments made in accordance with and subject to the terms and conditions set forth in the Terms and Conditions. Failure by the Contractor to submit complete and timely invoices may adversely affect payment thereof by National Grid.
- 6.3 Invoices shall reference the Contract Number, the name of the Owner's Field Representative who supervised the Work, and any Work Order number identified by the Owner's Field Representative.
