NOTICE REQUESTING COMMENTS

(Issued July 8, 2020)

The New York State Department of Public Service (DPS or Department) is seeking comment on PSEG Long Island's (PSEG LI) proposed Utility 2.0 Long Range Plan 2020 Annual Update (Utility 2.0 Plan). On June 30, 2020, in accordance with the Long Island Power Authority Reform Act (LRA), PSEG LI submitted the Utility 2.0 Plan to the DPS for review and recommendation. Pursuant to the LRA, the purpose of the Utility 2.0 Plan is to implement energy efficiency measures, distributed generation, or advanced grid technology programs providing customers with tools to more efficiently and effectively manage their energy usage and utility bills, and improve system reliability and power quality.<sup>1</sup>

Interested persons or parties are invited to submit comments on the Utility 2.0 Plan by August 24, 2020. Reply comments are requested by September 8, 2020.
