SUBJECT: CASE 13-G-0017 – Further postponement of a tariff filing by National Fuel Gas Distribution to make revisions to Service Classification No. 7 – Sales for Service for Natural Gas Vehicles.

SUMMARY OF

RECOMMENDATION: Staff recommends approval of the further postponement.

Discussion

National Fuel Gas Distribution Corporation (National Fuel) made a tariff filing to revise Service Classification No. 7 – Sales for Service for Natural Gas Vehicles (NGV) to allow for payment of service for fuel for NGV at the point of service. In its filing, National Fuel also requested approval for market-based and negotiated rate authority for NGV service. The filing had an effective date of May 1, 2013 but was subsequently postponed to July 1, 2013. National Fuel has agreed to further postpone the effective date of the filing to August 1, 2013 to allow additional time for Staff to complete its review. National Fuel has filed a supplement to implement the further postponement and requests a waiver of the requirement of newspaper publication of the change proposed by the supplement.

It is recommended that:

1. Supplement No. 50 to Schedule P.S.C. No. 8 – Gas be allowed to become effective on July 1, 2013; and
2. special permission be granted waiving the requirement of Section 66(12)(b) of the Public Service Law as to newspaper publication of the change proposed by the supplement.
