In accordance with the requirements set forth in the Order Authorizing Utility Energy Efficiency and Building Electrification Portfolios Through 2025, issued January 16, 2020 (the “Order”)<sup>1</sup>, Niagara Mohawk Power Corporation d/b/a National Grid (“National Grid”) is required to file a letter within thirty (30) days of the Order indicating its readiness to implement the Statewide Heat Pump Program by April 1, 2020.

Please be advised that National Grid will be ready to implement the Statewide Heat Pump Program by April 1, 2020, and will continue to collaborate with the other utilities and NYSERDA in order to meet this deadline.
