Schedule Revision and Public Statement Hearings -- Reforming the Energy Vision, Case 14-M-0101

**TO ALL PARTIES:**

The purpose of this note is to advise you of a revision to the Track Two schedule and to announce Public Statement Hearings.

The Track Two straw proposal anticipated by the end of January 2015 will be postponed until second quarter 2015. This postponement will permit Staff the opportunity to continue to explore Track Two issues, garner expert and/or stakeholder input where needed and, thereby, produce a more advanced work product that will provide a basis for stakeholder feedback. A comment schedule will be established when the Track Two straw proposal is issued.

In addition, Public Statement Hearings on Track One issues will be held at different locations across the state in early 2015. This effort will augment the record and further inform the Commissioners as they draw closer to rendering a decision in Track One. A formal notice designating the location and date of those hearings will be forthcoming.
