Re: Case 14-M-0196 - Tariff filing by Central Hudson Gas & Electric Corporation to establish fees for residential customers who choose to opt out of using Automated Meter Reading devices.

Dear Commissioners,

For simplicity, the following utility meter definitions will be used:

Analog Meter - A utility meter that contains no electronic components and is purely electro-mechanical.

Electronic Meter - A utility meter that contains electronic components and can utilize radiofrequency/microwave (RF/MW) for wireless transmissions or be non-transmitting.

In 2010, I learned that I was made ill by the radiation emissions from the digital electronic meters installed on my properties by Central Hudson and Con Edison. I documented this in the declaration below:

At that time, I notified Central Hudson, Con Edison and the New York State Public Service Commission (NYSPSC) about this. I assumed that the two companies and the NYSPSC would investigate the problem. The utilities did remove the offending meters and replace them with analog meters but to date, there has been no investigation.

Not long after that, other residents in New York State, including Central Hudson customers and more around the world, began reporting symptoms after the

installation of electric, water and gas electronic meters. This is documented in the following report by Dr. Ronald Powell:

Symptoms After Exposure to Smart Meter Radiation

Dr. Powell is a retired U.S. Government scientist (Ph.D., Applied Physics, Harvard University, 1975). During his Government career, he worked for the Executive Office of the President, the National Science Foundation and the National Institute of Standards and Technology. For those organizations, respectively, he addressed Federal R&D program evaluation, energy policy research, and measurement development in support of the electronics and electrical equipment industries and the biomedical research community. He currently interacts with other scientists and with doctors around the world on the impact on the environment – including the radiofrequency environment – on human health.

In 2010, I reported problems with the utility meters to Kenneth Resca, at the NYSPSC. He dismissed my concerns and told me to contact the Federal Communications Commission (FCC). See his e-mail below:

Soon after that e-mail, I contacted, by phone and e-mail, Robert Weller, Chief Technical Officer at the FCC. He too dismissed my concerns and told me that I should contact the NYSPSC about utility meters. See his e-mail below:

Good morning, Michele.

The FCC believes that the RF exposure from these devices is well within our guidelines. Therefore, we have no basis or authority to stop their installation or operation.

In many jurisdictions it is the state PUC that has ordered deployment of these devices. So, I might suggest that only the PUC can countermand those orders.

These are only two of the exchanges that I documented having with state and federal agencies and utility companies over the last six years. There are many more.

It is clear that from the beginning, electronic meters were approved and rolled out before the technology was understood. For this reason I founded Stop Smart Meters NY. We hired an expert RF/MW engineer to investigate and write a report about the RF/MW emissions from electronic utility meters.

The Isotrope Report investigates the following:

- 1. Transmitted non-stop puled RF/MW emissions pages 6, 7, 12
- 2. Conducted RF/MW emissions pages 9, 10, 12
- 3. The FCC fatally flawed laboratory testing pages 12, 15, 16

The Isotrope Report explains that in an FCC laboratory, the technicians testing an electronic meter, added a power cord to the meter. This is not the way that a utility meter works. A utility meter does not employ a power cord. The meter was altered to fit a test modality that was not designed for a utility meter. The test results were unrealistic and the test set-up was a failure. As a result the FCC approved the meters. The stage was set for other government regulatory agencies to approve electronic meters that were never properly tested.
