#### AGREEMENT

This Agreement made and entered into on the date when signed by the party signing last in time, by and between National Grid USA Service Company Inc. (Company), and Elecnor Hawkeye, LLC (Contractor), a limited liability company, having its principal place of business at 100 Marcus Blvd., Hauppauge, NY 11788, for the Work identified as:

#### **Utility Pole Support Services and Miscellaneous Electrical Services**

#### ARTICLE 1 - SCOPE OF WORK

The Contractor hereby agrees to provide all materials, equipment, apparatus tools, labor, Services, and facilities to perform all the Work in accordance with this Agreement. Work shall include, but not be limited to:

- Replacement of lights and bulbs on National Grid facilities and lighting structures in National Grid parking lots and yards
- Supply and install H-Frame and other structures for electric service at various locations
- Install temporary electric service to construction trailers or conexs' at job sites and removal of service
- Repair damage to traffic loops in the street. (Determine when signal light changes from red to green)
- Support utility poles during construction activities (typically with a derrick truck)
- Other miscellaneous services in support of National Grid's gas operations

This Agreement is effective February 17, 2015 through March 31, 2018.
