NOTICE REQUESTING COMMENTS

(Issued February 3, 2017)

The New York State Department of Public Service (DPS or Department) is seeking comment on PSEG Long Island's (PSEG LI) 2016 Utility 2.0 Long Range Plan Update (Plan). On December 29, 2016, in accordance with the Long Island Power Authority Reform Act (LRA), PSEG LI submitted to the DPS for review and recommendation its proposed 2016 Utility 2.0 Long Range Plan Update. In accordance with the LRA, the purpose of the Plan is to implement energy efficiency measures, distributed generation, or advanced grid technology programs providing customers with tools to more efficiently and effectively manage their energy usage and utility bills, and improve system reliability and power quality.

Interested parties are invited to submit comments on the topics enumerated above by March 6, 2017. Reply comments are requested by March 20, 2017. All comments filed with the Secretary will be posted to the Department's Web site. Comments will become part of the record considered by the Department in its review and development of recommendations.
