I. Introduction

On February 26, 2015 the New York State Public Service Commission ("Commission") issued *Order Adopting Regulatory Policy Framework and Implementation Plan* (the "Track One Order") in the Reforming the Energy Vision ("REV") Proceeding which directed electric utilities to file Energy Efficiency Budget and Metrics ("BAM") Plans and Energy Efficiency Transition Implementation Plans ("ETIPs") describing electric energy efficiency programs and initiatives proposed for the 2016-2018 three-year period. The Track One Order authorized 2016 utility electric energy efficiency portfolio budgets and targets. On June 19, 2015, the Commission issued *Order Authorizing Utility-Administered Gas Energy Efficiency Portfolios for Implementation Beginning January 1, 2016* directing gas utilities to implement gas energy efficiency programs and for electric and gas utilities to file tariffs implementing an electric and gas Energy Efficiency Tracker ("EE Tracker") by July 20, 2015. On January 22, 2016, the Commission issued *Order Authorizing Utility-Administered Energy Efficiency Portfolio Budgets and Targets for 2016 - 2018* establishing budgets and targets for electric and gas portfolios in 2017 and 2018 at the levels previously authorized for 2016.

This filing presents the 2017-2020 BAM Plans of Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid" or the "Company") for its electric and gas energy efficiency portfolios.⁴ The Company requests approval of the electric and gas portfolio budgets and targets proposed for 2018-2020. The Company's ETIPs, filed separately and concurrently with these BAM Plans, provide supportive information for the approval being sought from the Commission.

II. Electric & Gas Budgets and Targets

The January 2016 Order authorizes National Grid's electric and gas portfolio budgets and portfolio energy savings targets for 2017 and 2018. National Grid's proposals in the rate case include transitioning certain costs out of the electric and gas ETIP portfolios and into respective base rates beginning in 2018.⁵ As such, the Company proposes herein to maintain the same budget for 2018-2020 for the electric and gas portfolios as was previously authorized for 2018. National Grid proposes corresponding increases in the energy savings targets for each portfolio for 2018-2020 to reflect the additional program activities enabled by maintaining the same annual ETIP portfolio budgets.

Below are the 2017-2020 proposed budgets and targets for National Grid's electric and gas energy efficiency portfolios:
