2 (a) Conclusion: The table shown in 1(a) demonstrates that NYSEG and RG&E have complied with three of the four electric CAIDI and SAIFI targets. The exception is the SAIFI target at NYSEG with a measure of 1.35 and a noted revenue adjustment of \$7.0M.

Electric Reliability Events outside the Companies' Control

A provision in Appendix L in the current Rate Plan for NYSEG and RG&E (the "Companies") acknowledges the Companies' right to petition the Commission for a waiver associated with electric interruption events that are deemed to be outside of the Companies' control, if the impacts of those events are significant enough to cause the Companies to fail to meet the CAIDI and/or SAIFI targets set forth in the Rate Plan.

In 2019, the Companies tracked events of this nature with the largest of these events highlighted in the following tables. The Companies did not request the exclusion of these events for 2019; however, as shown in these tables, their impacts were significant.
