Re: Residence Basic Services – Rate Changes

Dear Secretary Brilling:

Verizon New York Inc. ("Verizon") submits the attached tariff amendments (Attachment 1), with an effective date of June 20, 2009. These amendments will increase the monthly charge for the residence local exchange access lines (1MR and 1FR) by \$1.95 per month. In conjunction with this rate increase, flat-rate usage rates will be reduced to the extent necessary to ensure that the total charge for flat-rated service does not exceed \$23.¹ The filing will not increase Life Line charges; indeed, total flat rate service for Life Line customers will be reduced in Rate Groups 3, 5, 7 and 9.²

This price increase will generate needed additional short-term revenues for Verizon, as the company faces the dual financial pressures created by competitive access line losses and the costs of building out an advanced voice/video/data network in the State. As the Commission has noted, Verizon's financial condition is "relevant" when the Commission considers pricing changes because "the state has an interest in a viable company. This is especially important given the magnitude of the company's capital investment program, including its massive deployment of fiber." "There seems to be little question that the company is in need of financial relief; Verizon [New York] reported an overall intrastate return of a <u>negative</u> 4.89% in 2006 and its reported intrastate return on

common equity was a <u>negative</u> 73.6%.³ For 2007, Verizon reported an overall intrastate return of negative 6.24% and an intrastate return on common equity of negative 46.0%.

Moreover, this price change will encourage the migration of customers towards higher-value service bundles, consistent with the trend toward bundled service offerings in the market as a whole.

The proposed increase will not unduly burden Verizon's customers. Flat-rated service, at a total rate of no more than \$23.00 per month, will remain available in all parts of the State other than New York City. In the City, the Unlimited Local Plan will remain available and will provide an access line plus unlimited local usage for a total of \$23.00 per month.⁴ Verizon also offers other service bundles that provide greater functionality (e.g., calling features, toll and long-distance usage, etc.) at only modestly higher prices.⁵ Further, residential customers have numerous competitive alternatives to Verizon's service, as the Commission recognized in the *Competition III Order*.

An analysis of the revenue effect for this filing is attached (Attachment 2). Certain competitively sensitive information related to this filing has been deleted from the attached copy of the supporting material. An unredacted copy is being provided to Steven Blow, Records Access Officer, pursuant to a request for trade secret protection.

Verizon will arrange for newspaper publication of this filing in accordance with the Public Service Law. Customers will also be given notice of the filing in a May bill insert.

⁴ The Unlimited Local Plan ("ULP") is a residential calling plan available to customers in the New York Metropolitan Area LATA that provides unlimited calling within the subscriber's "Home Region" (the Metro LATA equivalent of a local calling area). See Verizon Tariff PSC No. 2, § 0(X). A customer in the Metro LATA can purchase the ULP at \$9.15 a month (Verizon Tariff PSC No. 2, § 1, Rate Attachment, § X(4)). When added to the current access line rate of \$13.85, this results in a total intrastate rate of \$23.00 per month. The attached filing reduces the ULP rate by \$1.95 to offset the proposed increase in the access line rate.
