NOTICE OF PUBLIC STATEMENT HEARING

(Issued January 30, 2020)

On June 7, 2019, Hecate Energy Albany 1 LLC and Hecate Energy Albany 2 LLC (Hecate Albany), wholly owned subsidiaries of Hecate Energy LLC, filed an application seeking authority to build and operate the Coeymans Solar Farm, a commercial-scale solar photovoltaic electric generating facility in the Town of Coeymans, Albany County (the Project). The Project would consist of arrays of ground-mounted photovoltaic solar panels installed on a 436-acre site, with a total Project capacity of 40 megawatts. The proposed Project site is located between United States (US) Route 9W and Albany County Route (CR) 101. Points of interconnection with the electric grid would be to existing National Grid 115 kilovolt transmission lines that cross the southern portion of the Project site.

On January 22, 2020, the Chair of the New York State Board on Electric Generation Siting and the Environment (Siting Board) determined that the Hecate Albany's application complies with the Siting Board's filing requirements. **PLEASE TAKE NOTICE** that opportunities for public education and comment will be provided in this case as follows:

At the Informational Forums, the Examiners will provide an overview of the Siting Board's certification process and the Developer will present a brief summary of the proposed project. A map of the proposed project area will be available for viewing. Members of the public will then have an opportunity to pose questions about the process and the certificate application pending before the Siting Board.

At the Public Statement Hearings, any person wishing to provide a public statement must complete a request card, and the Examiners will use the request cards to call each person who has requested to provide a statement on the record. Reasonable time limits may be set for each speaker as necessary to afford all attendees an opportunity to be heard. Lengthy comments may be submitted in writing and summarized for oral presentation. A verbatim transcript of the hearing will be made for inclusion in the record of this case.
