It is anticipated that the parties will file a Joint Proposal prior to this procedural conference. Assuming that this filing is made, the purpose of the procedural conference is to address the date for filing of Statements in Support or Opposition to the Joint Proposal, the date for the hearing with respect to the Joint Proposal, and any other procedural issues that may be raised by the parties.

Active participation in this conference will be limited to those who have become parties. Those interested in becoming a party are encouraged to become a registered user of the Public Service Commission's Document and Matter Management

(DMM) System and to submit their request for party status through the DMM system. To become a registered user, from the Department website home page ([www.dps.ny.gov](http://www.dps.ny.gov)), select the DMM Login icon and then select "Create an Account now." Once you have a DMM account you may seek party status by searching with the applicable Case Number (i.e. 16-E-0060 or 16-G-0061) and then selecting "Request for Party Status" in the upper right corner of the page. Those who seek and are granted party status at this stage of the proceeding are advised that they will take the record as it currently exists.

All persons (including both parties and non-parties) attending the conference must provide their name to the ALJ's secretary, Ms. Kelly Achzet, via e-mail ([Kelly.Achzet@dps.ny.gov](mailto:Kelly.Achzet@dps.ny.gov)) or by telephone at (518) 474-4521 before noon on Tuesday, September 20, 2016, and must be prepared to show valid photo identification upon arrival at 90 Church Street.
