
We represent Galloo Island Wind, LLC ("Galloo Island Wind") in the above referenced proceeding. Galloo Island Wind recently submitted a Preliminary Scoping Statement ("PSS") for the proposed Galloo Island Wind Project ("Project"). Pursuant to 16 NYCRR 1000.5(g), comments on the PSS were due in 21 days (by June 27, 2016). The Department of Health ("DOH") submitted comments to the PSS on July 8, 2016, 10 days after the submission deadline. Galloo Island Wind hopes to adhere to the original response deadline of July 18, 2016, 21 days after the comment deadline, but may require an extension to incorporate these late filed comments. We will advise your office if an extension is requested.

The Siting Board has previously commented on the strict timeframes in Article 10 and the need to adhere to proper procedures and schedules to allow for an orderly and efficient process. We appreciate the Siting Boards continued vigilance in this regard.
