Dear Secretary,

The New York State Public Service Commission ("Commission") requires a qualified ESCO to submit a statement annually by January 31st indicating whether the previous ESCO-related information on file with the Commission remains current, and if not, to identify any revisions. It is CEGC's intent to maintain its ESCO eligibility in New York by continuing to submit the required Annual Compliance Filing.

CEGC's existing Retail Access Application Package has the following update. Constellation Energy Gas Choice, Inc. ("Licensee") changed its name to Constellation Energy Gas Choice, LLC effective December 31, 2015 at 11:59 pm. The Licensee's conversion from a corporation to an LLC and associated name is part of an ongoing corporate restructuring. Given the fact that there will be no changes to any existing customer contracts and only minimal changes to any marketing materials where the whole legal entity's name appears, rather than the shortened use of "Constellation", Licensee does not intend to send notifications to customers informing them of the name change. Further, the name change will not otherwise impact the legal ownership, or management of Licensee in any way. Licensee's DUNS number and Federal Tax Identification Number also remain unchanged. Attachment A is the Secretary of State documentation of the Licensee's name change to Constellation Energy Gas Choice, LLC. Licensee is also providing an updated corporate structure chart reflecting the name change as of January 1st 2016 as Attachment B.

In addition, ESCOs must notify the Commission if there have been any updates to the Third Party Vendor Information previously provided. CEGC's current Third Party Vendors are listed on TRADE SECRET Attachment C.

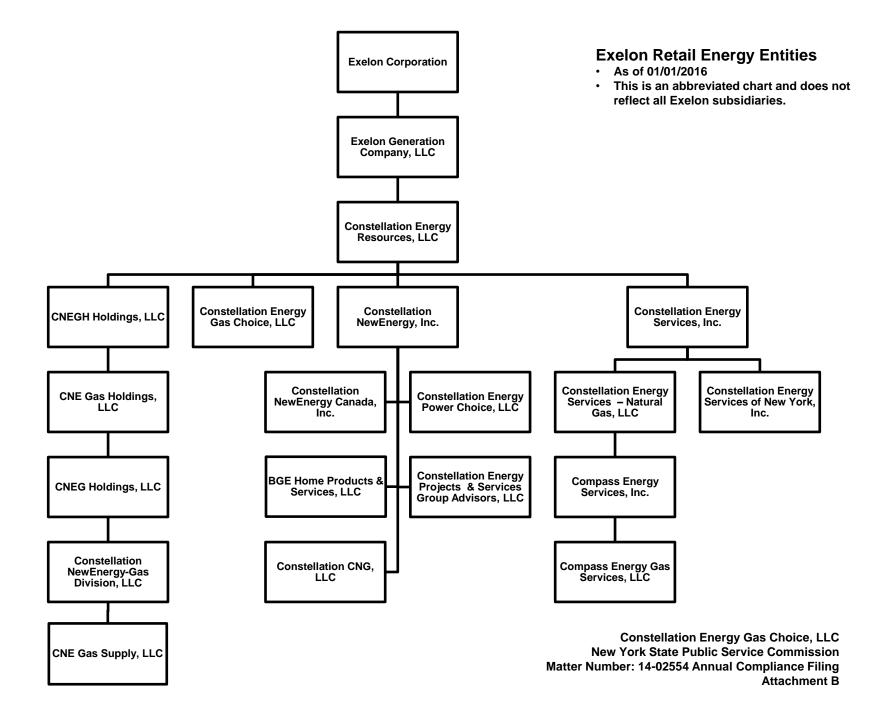
