Our firm represents Galloo Island Wind, LLC ("Galloo Island Wind") in the above referenced proceeding before the Siting Board on Electric Generation and the Environment ("Siting Board") under Article 10 of the NY Public Service Law ("Article 10"). Galloo Island Wind hereby seeks a short extension of the deadline to file a summary and response to material comments on the Preliminary Scoping Statement ("PSS"), as required by 16 NYCRR § 1000.5(g). The current deadline for Galloo's response is July 18, 2016. Galloo requests that the deadline be extended to July 22, 2016, a four day extension.


The extension is necessary in order for Galloo to complete the responses to comments on the PSS (including comments which were submitted after the deadline for comments). This request is in the interests of ensuring the orderly, fair and efficient administration of this proceeding and none of the parties will be prejudiced or adversely affected by this short extension.
