NOTICE REQUESTING COMMENTS AND ANNOUNCING PUBLIC STATEMENT HEARING AND PROCEDURAL CONFERENCE

(Issued May 1, 2024)

Comments are requested concerning a June 14, 2023 petition filed by Alle-Catt Wind Energy, LLC (Alle-Catt) pursuant to Section 68 of the Public Service Law (PSL) for a Certificate of Public Convenience and Necessity (CPCN), to establish lightened regulation as an electric corporation, and to approve construction financing associated with a 340-megawatt wind electric generation project (Project). The petition and related documents may be reviewed by going to www.dps.ny.gov, clicking on "File Search" (located under the heading "Commission Files"), entering "23-E-0391" in the search box, and then clicking on the "Search" button.

In related proceedings, on June 3, 2020, the New York State Board on Electric Generation Siting and the Environment (Siting Board) granted Alle-Catt a Certificate of Environmental Compatibility and Public Need (CECPN) to construct and operate the Project pursuant to Article 10 of the PSL. On February 10, 2021, Alle-Catt filed an application with the Public Service Commission (Commission) for a CECPN pursuant to Article VII of the PSL to construct a 10-mile transmission line interconnecting the Project with a Niagara Mohawk Power Corporation d/b/a National Grid 345 kV transmission line at the Homer City-Stolle Road switchyard in the Town of Yorkshire (the Transmission Facility). The Transmission Facility will connect the Project to the State's electric grid. On March 3, 2022, the Commission

found the CECPN Article VII application for the Transmission Facility to be complete and it is currently pending before the Commission (Case 21-T-0059).

The scope of the Commission's review of the CPCN petition that is the subject of this Notice will not duplicate the issues that were previously considered and decided by the Siting Board in its 2020 order or the issues that are currently pending before the Commission for the Transmission Facility.
