STATUS OF ENERGY AFFORDABILITY IN NEW YORK

The February 14, 2024 press release¹ for the NY Comptroller report² "New Yorkers in Need, The Housing Insecurity Crisis" described the housing crisis. The Individual Intervenors believe that increases in energy costs will exacerbate the problem. The report notes that:

York had 2.9 million households paying 30 percent or more of their income for housing. This constituted 38.9 percent of households, the third highest rate of housing cost burden among states. Approximately 20 percent of New York households were severely cost-burdened, paying more than 50 percent of their income for housing.

New York consistently ranks as one of the states with the highest cost burdens for both owners (3rd in 2022) and renters (13th in 2022). The share of New York's renters who are cost burdened (52.4 percent) is far greater than the share of homeowners (28.0 percent). High rental burdens are a problem in regions across the state, but are more prevalent in urban areas
