CONSTRUCTION SERVICES AGREEMENT

This Construction Services Agreement, made and entered into on the date when signed by the party signing last in time, by and between **Niagara Mohawk d/b/a National Grid** ("Owner" or "Company"), a New York corporation, with offices at 300 Erie Boulevard West; Syracuse, New York, 13202 and **AGI Construction** having its office and principal place of business at 34 Appian Way, Smithfield, Rhode Island, 02917.

ARTICLE 1 - SCOPE OF WORK

Contractor shall provide or perform the Work (as defined in Schedule A-1) or cause the Work to be provided or performed, in accordance with the terms of this Agreement including the Project Specification, Construction Standards, Construction Procedures, Safety & Environmental Standards, drawings and all other Contract documents in the Agreement to which reference is made, together with the Agreement, are intended to cover all supervision, labor, materials, equipment and all else requisite and proper beyond what is provided by National Grid, necessary for the successful completion of all work detailed and described as UPNY Main Replacement Project. In any case where this Specification may contradict referenced Specifications or Standards, this Specification shall govern including all Project Drawings, Project Documents, Construction Standards, Construction Procedures, Safety Standards and all other documents referenced therein). Any changes to the Scope of Work which result in a change to the Contract Price must be authorized in writing prior to performing the Work.

ARTICLE 2 - CONTRACT DOCUMENTS

The following documents, including all attached schedules, appendices, exhibits or other attachments thereto, are incorporated by reference as if fully set forth herein, and are hereinafter referred to collectively and individually as the "Contract Documents" that make up the Agreement. The Agreement is comprised of the following:

ARTICLE 3 - AGREEMENT DURATION

The Agreement shall commence on or about June 3, 2015 and proceed to on or about December 25, 2015.

ARTICLE 4 - SCHEDULE

Any Work performed under this Agreement shall be completed in accordance with the Project schedule (Schedule G). The Contractor agrees to comply with the Project Schedule as requested by National Grid in order to successfully complete all work on or about December 31, 2015. The Owner reserves the right, at its sole option, to cancel this Agreement at any time and for any reason.

<u>ARTICLE 5 - CONTRACT PRICE</u>

This Purchase Order is issued on a Crew Rate pricing basis (Schedule H) as set forth in AGI Construction final proposal dated May 21, 2015. The Contract Price shall be the total price to be paid by the Owner to the Contractor in accordance with the prices set forth in the proposal, unless otherwise agreed to in writing by the Owner and the Contractor.

Contractor will be responsible for all labor productivity required to achieve their quoted price. As stated at the pre-bid meeting, the Contractor shall not exceed 10% of their estimated cost for their assigned projects(s) and will be evaluated on the first project to receive approval prior to moving forward with additional locations.

The Crew rates shall be all inclusive for performing natural gas main and service installations within National Grid's (NG) service territories. All personnel shall have the applicable Operator Qualifications under the Northeast Gas Association (NGA) plan, NGA PE pipe joining certification, and in compliance with all the latest revisions to National Grid Gas Policies and Work Methods as accessed through the NG Work Methods online website.

Unit rates shall be all-inclusive, including but not limited to: all labor & equipment, fuel, insurance, taxes, profit, overhead, FICA, Worker's Compensation, holiday pay, and daily Per Diem (when applicable) and/or meal stipends. In addition, road plates and trench protective systems (e.g. shoring) are going to likely be required periodically. These items shall be readily available, when required, and the transport/delivery shall be inclusive to the crew rates.

Unit Terms: Price Per Hour: Straight Time / Overtime- NG requests that after 8 hours of straight-time, all equipment & tooling costs are covered (fully compensated) for the day. Overtime rates shall include only the incremental labor costs associated with premium time compensation, i.e. "over time" or "time and a half".

The Contract Price shall be all inclusive for the Work required by this Agreement in accordance with all the Contract Documents including, but not limited to, the Terms and Conditions).

ARTICLE 6 – SAFETY

1. The Contractor assumes complete responsibility for the safe performance of the Work and shall comply fully with:

a. National Grid Safety Procedure N-1402 dated 9/11/13 (Schedule C)

b. National Grid General Safety Requirements (SHE01001 Rev. 1)

<u>ARTICLE 7 – LIMITATION</u>

The Contractor shall not revise the scope of work or deliverable products contained therein

or incur costs to National Grid's account in excess of the Contract Price without National

Grid's prior written approval; such approval to be incorporated by formal amendment to this

Agreement.

<u>ARTICLE 8 – UNAUTHORIZED DISCLOSURE</u>

The Owner considers any information provided to the Contractor in the course of business

to be privileged and confidential between the Contractor and the Owner. This includes, but

is not limited to, written data of any kind, business information, request for proposals,

specifications, engineering data and any and all technologies and data either obtained or

observed while supplying the commodity/service required by the Agreement. Unauthorized

disclosure of information to third parties by you may lead to cancellation of the Agreement,

loss of future business opportunities and/or the effects of any other remedies that may be

available to the Owner.

<u>ARTICLE 9 – NOTICES</u>

Where written notice is required by this Agreement, such notice shall be deemed to be

given when delivered personally, mailed by certified mail, postage prepaid and return

receipt requested, or by facsimile or electronic mail, as follows:

<u>ARTICLE 10 – ACKNOWLEDGEMENT</u>

The Contractor agrees that it will not be entitled to payment until this Agreement is signed and returned to the National Grid Procurement Department. In the absence of The Contractor's written acceptance, performance of any part of the Work provided for by this Agreement shall constitute acceptance of all provisions of this Agreement.

<u>ARTICLE 11 – MISCELLANEOUS</u>

This Agreement cannot be changed, altered, modified, amended, waived or discharged orally. Any such changes, alterations, modifications, amendments, waivers, or discharges can only be made effective when embodied in a written change order signed by an authorized representative or officer of the Owner and the Contractor.

The Agreement, as the same may be amended from time to time in writing by a change order, sets forth the full and complete understanding of the parties regarding the services to be performed by the Contractor for the Owner and supersedes any and all prior and contemporaneous agreements, commitments, understandings, and discussions, whether written or oral, which may have existed relating to the services to be performed by the Contractor. This Agreement shall not merge with or be terminated or superseded by any future agreement between the Parties that does not specifically so provide and without an Agreement Change to that effect.

ARTICLE 12 - ENTIRE AGREEMENT

This Agreement, including all Contract Documents, constitutes the entire Agreement between the Owner and the Contractor, with respect to the Work. No modification of any of the provisions of this Agreement shall be binding unless in writing and signed by a duly authorized representative of each party hereto.

IN WITNESS WHEREOF, each party hereto has caused this Agreement to be executed by its duly authorized representative on the day and year set forth below. THE PARTIES HAVE READ AND UNDERSTAND THIS AGREEMENT AND AGREE TO BE BOUND BY ITS TERMS.
