Re: Matter No. 21-01932 – Petition of Verizon New York Inc. for an Order of Entry for 185 Avenue C, Manhattan.

To Whom It May Concern:

By Verified Petition filed September 9, 2021, Verizon New York Inc. requests that the Commission issue an Order of Entry, pursuant to 16 NYCRR §898.4, to gain access to the premises located at 185 Avenue C, Manhattan, New York in order to install cable television facilities in the building. Public Service Law (PSL) §228(1) states, in part, that no landlord shall interfere with the installation of cable television facilities upon the premises, except that a landlord may require that the installation of cable television facilities conform to such reasonable conditions as are necessary to protect the safety, functioning and appearance of the premises, and the convenience and well-being of other tenants.

Under 16 NYCRR §898.4(b)(9), you have the opportunity to respond within twenty (20) days of receipt of the Verified Petition. Your participation is not mandatory, however, if you choose not to respond in this matter, the Commission may grant the requested Order of Entry, which will constitute a ruling that Verizon has complied with PSL §228 and 16 NYCRR §898.

It has been twenty days since the Verified Petition has been filed. If you still wish to respond, please reply within ten business days from the receipt of this letter to ensure that it may be considered in this proceeding. Pursuant to the regulations, your reply must be responsive to Verizon's petition and may set forth any additional matter not

contained in the petition. Any previous response by you to Verizon regarding access to the premises will <u>not</u> be considered a reply to the Verified Petition; you must reply directly to the Commission in order for it to be part of the official record.
