#### 2) **24-month meter data:** Josh Pasquariello

a. Feedback received from NYSEG RGE. Still waiting on other utilities to provide feedback.

#### 3) **O&R EDI System Issues:** Matt Sigg (Constellation)

- a. Not receiving EDI responses. Responses not being received from 814 enrollment and other historical usage documents. The issue originated from a massive Historic Usage request came from over 160,000 requests on August 31. The surge of requests prompted the issue. This issue extends to ConEd as well.
- b. Matt asks will there be a transmission of backlogged data and/or a notification indicating that there was an issue with the original transmission. O&R states some of the previous responses have started to trickle out.
- c. O&R confirms there have been technical issues since early September. O&R IT team is working on the issue and will keep all parties updated on the matter.
- d. Vistra Energy asks how will updates be communicated. O&R confirms they will be communicating with suppliers any updates as they arise. Con Ed confirms they will also notify any suppliers about the issue.
- e. EDI Providers state there is an issue with their receiving the updates on technical issues. ESCOs are the ones who receive the updates, but EDI providers are supposed to get updates passed to them by the ESCOs.
- f. O&R states they send out emails about technical issues, and state they will send out the notifications to EDI providers as well.

- a. GISB 1.6 upgrade
  - Update from utilities not marked complete
    - -request from Kim to update completion dates.
  - ii Scheduled completion dates in the past
- b. TLS 1.0
  - i Updates from utilities
    - -Questions are outdated and need to be updated by utilities. Kim W asks if ESCOs on TLS 1.0 will be required to stop using it.
  - ii Scheduled completion dates in the past

- -Kim W requesting feedback from utilities to ensure if completion dates were met. Requests they be updated if need be.
- iii Future of TLS 1.0 (additional versions, ECSOs to stop using, etc.?)
  -Feedback needed from utilities to answer these questions. Will ESCOs be forced to stop using TLS 1.0 and be required to use an updated TLS security measure?

#### 5) Net metering: Kim Wall – How can ESCOs determine the following?

- If customer has legacy net metering (where kWh carried forward instead of monetary credit
- b. If customer is participating in Value Stack
- c. If customer is participating in Community Distributed Generation
- NYSEG RGE -There is no indicator for ESCOs to know whether a consumer has legacy net metering, value stack, or is CDG.
- -No other utilities replied.
