Overview	This document describes your Community Solar subscription. In the event that the terms in this statement conflict with terms appearing elsewhere in your contract, the terms in this statement are controlling. Read this document and the contract carefully so that you fully understand this agreement.
Price, Fees, and Charges	The Subscription Rate during the Initial Service Term is a ten percent (10%) discount to the Electric Utility's rate, calculated as: ninety percent (90%) multiplied by the published variable electricity rate under Your Electric Utility Account's service classification with the Electric Utility.
Project Location and Customer Allocation	The clean energy project will be in located in your utility's coverage area in New York State. Your allocation of the project's generation will be based on 75-90% of Your electricity usage over the previous twelve months. Common Energy will notify you via email when Your account has been successfully connected to a project, and provide You with additional details including project location and size.
Length of Agreement and Renewal	Terms: 5.0 years After five years, the agreement will renew automatically for one year, up to twenty-five years
Early Termination	This Agreement may be terminated by you at no cost at any time so long as you provide Common Energy with 90 days' advance notice, subject to your payment for any Bill Credits that you receive from the Electric Utility before your termination is processed. If you cancel without providing 90 days notice you will be charge a one-time cancellation fee of \$100.00.

Estimated Benefits	<p>The project will generate kWh bill credits. On average, each subscriber will receive 7600 kWh bill credits each year. On average, the expected monetary value of the bill credits is expected to be \$680.</p> <p>Or, in the case of a monetary project:</p> <p>[The project will generate monetary bill credits. On average, each subscriber will receive monetary bill credits with an expected value of \$580 each year.]</p>
Guarantees	<p>This contract guarantees that you will save 10% off of your utility's rate for Bill Credits, as detailed in the contract. This contract does not guarantee a minimum level of system performance or production of energy.</p>
Data Sharing and Privacy Policy	<p>You authorize Common Energy to obtain Your Electric Utility Account number, historical electricity consumption data, current and historical electricity rate data, and other energy-related data (the "Utility Data") from the Electric Utility.</p>
Right to Cancel Without Penalty	<p>You have the right to terminate the contract without penalty within three business days after signing the contract by notifying Provider at support@commonenergy.us or 1-844-899-9763.</p>
Customer Rights	<p>If you have inquiries or complaints that the Provider is unable to resolve, you have the right to call the Department of Public Service Helpline at 1-800-342-3377.
