

**TO ALL LANDOWNERS OF LAND ON WHICH ANY PORTION OF THE FACILITY PROPOSED IN NATIONAL GRID'S PUBLIC SERVICE LAW ARTICLE VII CERTIFICATE APPLICATION TO THE PUBLIC SERVICE COMMISSION IS TO BE LOCATED:**

Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid") intends to file an application (the "Application") on or about November 18, 2022 with the New York State Public Service Commission ("PSC") pursuant to Public Service Law Article VII requesting a Certificate of Environmental Compatibility and Public Need to allow National Grid to construct and operate its proposed Lockport-Batavia Line 112 Rebuild Project in the Counties of Niagara and Genesee, New York ("Project").

National Grid's existing Lockport-Batavia Line 112 is a 115kV electric transmission line approximately 35 miles in length, running between National Grid's Lockport Substation in the City of Lockport, Niagara County, and its Batavia Substation in the City of Batavia, Genesee County. The Project is National Grid's proposal to rebuild approximately 21.7 miles of the existing line. The western end of the Project would be immediately east of the first structure (Structure 1-2) of the existing line, which is located just outside the Lockport Substation. The eastern end would be at (and include) the line's Structure 211 in the Town of Alabama. The Project would rebuild all of existing Line 112 between those two structures, except for an approximately 1.9-mile section thereof (called "Segment 6") on the site of the Western New York Science and Technology Advanced Manufacturing Park (known as "STAMP") being developed by the Genesee County Economic Development Center, which is not part of the Project. (The resulting rebuilt portion of the line is referred to as "Rebuilt Line 112.") Most of Rebuilt Line 112 would be located along the same centerline as existing Line 112. One segment (called "Segment 4") would be relocated approximately 0.2 miles to the northeast of the existing line. The new route of Segment 4 would run approximately 2.2 miles along the south side of Lewiston Road (NYS Route 77 in the Town of Alabama) and along the west side of Feeder Ditch Road. Both the existing and the relocated routes of Segment 4 are in the Tonawanda State Wildlife Management Area.

Your property may be impacted by this Project.

After the Application has been filed and the PSC has assigned it a case number, interested persons who wish to participate as parties in this case may file a notice of intent to be a party in the case. This may be done through the PSC's web site. From the home page of the PSC's web site (<http://www.dps.ny.gov>), a prospective party should click on "Search". Under "Popular Searches", select "Latest Cases/Matters started". In the "Search" section on the right side of the web page that appears, enter "Lockport-Batavia Line 112". Then, in the "Search Results" at the

bottom of the page, click on the Case/Matter number on the left side. This will bring the user to the main Document and Matter Management (DMM) page for this case. On that page, the prospective party should click the button at the upper right labeled "Request for Party Status" to see a web page with instructions for the procedures to follow to become a party. The timeframe for filing a request to be a party to this case is throughout the pendency of the case.

#### Ways to Comment to the Commission:

Via the Internet or Mail: The public may submit comments by email to the Hon. Michelle L. Phillips, Secretary, at [secretary@dps.ny.gov](mailto:secretary@dps.ny.gov) or by mail to Secretary Phillips at the New York State Public Service Commission, Three Empire State Plaza, Albany, New York 12223-1350. Comments may also be entered directly into the case file for this matter by clicking on the button at the upper right labeled "Post Comments" on the main DMM page for this case (see above).

Via the Commission's Toll-Free Opinion Line: Individuals may choose to submit comments by calling the Commission's Opinion Line at 1-800-335-2120. This line is set up to receive in-state calls 24 hours a day. These calls are not transcribed but a summary is provided to the Administrative Law Judge who will report to the Commission.

All comments should refer to the case number. All comments will become part of the record considered by the Commission. Comments will be accepted throughout the pendency of this case. Also on the main DMM page for this case (see above), one can click on the "Public Comments" tab to read written comments, and on the "Filed Documents" tab to see other documents such as the application and transcripts of public statement hearings. A copy of the Application will be available in a number of public libraries close to the Project site on or shortly after the date the Application is filed with the Commission. In addition, copies of the Application will be available for public inspection at the Department of Public Service Offices in Albany (Office of Central Files, 14th Floor, Three Empire State Plaza, Albany, NY 12223). Many libraries offer free internet service, which can be used to obtain access to the Commission's website, including the DMM.
