CASE 24-G-0630 - In the Matter of a Review of the Long-Term Gas System Plan of Liberty Utilities (St. Lawrence Gas) Corp.

NOTICE REQUESTING COMMENTS AND  
ANNOUNCING TECHNICAL CONFERENCE

(Issued February 11, 2025)

In its Order Adopting Gas System Planning Process, issued May 12, 2022, in Case 20-G-0131 (May 2022 Order), the Public Service Commission (Commission) created a long-term gas system planning process for local gas distribution companies<sup>1</sup> and directed Department of Public Service staff (Staff) to facilitate meetings among each gas utility and the stakeholders interested in that gas utility's long-term plan, including assisting in resolving any disputes regarding requests for information.<sup>2</sup> Pursuant to that process, Liberty Utilities (St. Lawrence Gas) Corp. (Company) filed its initial long-term plan on January 31, 2025. Staff advises that stakeholders will have multiple opportunities to participate in the review of the Company's long-term plan.

**PLEASE TAKE NOTICE** that initial comments from stakeholders and other interested entities concerning the substance of the initial long-term plan filed by the Company are requested by **April 28, 2025**, with reply comments requested by **May 16, 2025**.
