# Case No. 12-M-0476 et al. EDI Business Working Group (BWG)/ Technical Working Group (TWG) Draft Minutes – March 15, 2019

## **Administration**

- Review/Modify Agenda: The Draft Agenda was adopted with a modification to the date for the next meeting.
- The Draft Minutes from the 2/15/2019 meeting were adopted as final with a modification to the attendance list.
- DPS Staff Remarks: None.

# **Regulatory Update**

There were no regulatory actions since the last working group meeting that directly impacted EDI.

## **Annual Review of EDI Roster**

EDI Working Group attendees were asked to review the current roster and provide updates to the BWG Chair or Rebecca Sweeney (DPS Staff). Updates have been received; working group member should continue to send them.

## **Updates to EDI Implementation Plan(s)**

Except for National Fuel, there were no updates. Mike Novak (National Fuel) noted that the 814C REF~5E segment has been in production since December 2018 and that National Fuel will discontinue providing its ineligible customer secure web-file sometime in April 2019. Amy Delooza (Agway) asked if National Fuel would still be updating its sync list web-file. Novak replied affirmatively and noted that an ineligible customer status flag had been added to the sync list.

# **GISB EDM 1.6 Implementation Update**

National Fuel noted they had slipped a bit on their implementation schedule but still hoped to complete the GISB 1.6 implementation (including implementation of 1024-bit keys, where appropriate) by the end of May. National Fuel believes testing will primarily involve EDI Service Providers and ESCOs that process EDI in-house.

Pete Foster (NYSEG/RG&E) noted that their GISB 1.6 implementation plan will include implementation of 1024-bit encryption keys. With respect to other GISB 1.6 implementation issues, Foster said NYSEG/RG&E would prepare a workpaper for discussion at an upcoming working group meeting.

#### 867MIU/HIU - ConEd Gas Implementation

During prior working group meetings, Eric Heaton (ConEd) explained their plans to soon start sending Historical Usage and Monthly Usage for gas interval meters in hourly intervals. Sample EDI files in PDF format were posted as workpapers for this meeting.

Heaton noted that notice of the upcoming gas implementation was provided in their ESCO bulletin. Kim Wall (Hansen) asked if the gas implementation would have the same issue with missing interval last days as the electric implementation. Heaton thought electric legacy accounts might be the root cause of the issue and that the gas implementation would not have legacy accounts. Mary Do (Big Data Energy) asked if third party providers received the bulletin; Heaton said to check their web site at: <a href="https://www.coned.com/en/business-partners/become-a-supply-partner/energy-service-company-news">https://www.coned.com/en/business-partners/become-a-supply-partner/energy-service-company-news</a> . Tom Dougherty (Marketwise) asked for an explanation of legacy accounts; Heaton explained these accounts had pre-AMI interval usage data.

#### **Removal of Meter Data Service Provider References**

The BWG Chair reviewed a workpaper prepared in response to the Order in Case 18-E-0595 - In the Matter of Meter Service Provider/Meter Data Service Provider Programs which terminated Meter Service Provider (MSP) and Meter Data Service Provider (MDSP) programs, as established by order issued on January 31, 2001, in Case 00-E-0165, et al. The workpaper showed references to meter data service provider (MDSP) to be removed in TOP Supplement 1, the 810 URR Business Process Document and the 867MU Implementation Guide. There we no questions from the working group; these changes will be reflected in the next EDI Report filing.
