## NOTICE ANNOUNCING TECHNICAL CONFERENCE AND SOLICITING COMMENTS

(Issued November 15, 2023)

On March 27, 2023, Department of Public Service staff (DPS staff) filed a Whitepaper Regarding Marginal Cost of Service Studies (Whitepaper) in the above-captioned proceeding. The Whitepaper makes various recommendations for the preparation of Marginal Cost of Service (MCOS) studies by Central Hudson Gas & Electric Corporation, Consolidated Edison Company of New York, Inc., New York State Electric & Gas Corporation, Niagara Mohawk Power Corporation d/b/a National Grid, Orange and Rockland Utilities, Inc., and Rochester Gas and Electric Corporation (collectively, the Joint Utilities). These MCOS studies would be used to, among other things, calculate the Locational System Relief Value (LSRV) and the Demand Reduction Value (DRV) elements of the Public Service Commission's Value of Distributed Energy Resources Value Stack Compensation, addressed under Case 15-E-0751. On July 20, 2023, and August 18, 2023, parties to this proceeding filed comments and reply comments, respectively, on the proposals put forth in the Whitepaper.

PLEASE TAKE NOTICE that a virtual technical conference will be held on November 28, 2023, beginning at 10:00 a.m. The conference will provide an opportunity for DPS staff and interested parties to engage with the Joint Utilities regarding the proposal made by the Joint Utilities for the first time in their initial comments. The Joint Utilities will provide

further explanation of their proposal to use a deferral value approach for MCOS in LSRV areas and for Non-wires Solution areas. The Joint Utilities propose to use the traditional MCOS studies for territory-wide programs and the DRV.
