Moratorium on Utility Service Terminations and Disconnections of Residential and Small Business Customers during the COVID-19 State of Emergency

Dear Secretary Phillips:

In accordance with the Department of Public Service Guidance, submitted herewith for filing on behalf of all of the Town of Liberty Water Districts ("District") are: (a) the District's overall plan for implementing the May 11, 2021 amendments to Public Service Law section 89-1 ("PSL Amendments"); and (b) the notice to customers pursuant to Public Service Law section 89-1(5).

- 1. The Town has reviewed and will follow the PSL Amendments and accompanying Department of Public Service Guidance dated May 24, 2021
- The Town will not terminate or disconnect any residential municipal water for the nonpayment of bills, taxes or fees for the duration of the COVID-19 State of Emergency or at any time when the customer is in compliance with the terms of the deferred payment agreement, or July 1, 2022, whichever is earlier
- In the event the Town has terminated or discontinued any residential municipal water and termination or discontinuance was made during the pendency of the COVID-19 State of Emergency, the Town will restore service with 48 hours
- 4. Pursuant to Public Service Law section 89-1(5), the Town will provide written notice to District customers of the PSL Amendments on COVID-19 customer protections, along with (a) Residential Customers Payment Deferral Agreement Request Form, and (b) Small Business Customers Payment Deferral Agreement Request Form, each of which includes a COVID-19 self-certification. A copy of which are enclosed and the foregoing will also be posted on the Town's website and at the Town of Liberty Government Center
- The Town will accept a residential customer's and small business customer's self-certification that the customer has experienced a change in financial circumstances due to the COVID-19 State of Emergency
- 6. Those residential customers and small business customers who sign the self-certification will not be disconnected or terminated for non-payment until after the disconnection protection period ends, which will be 180 days from the date upon which the current COVID-19 State of Emergency is terminated, or July 1, 2022, whichever is earlier

- 7. The Town's residential customers will be provided with the right to enter into a Deferred Payment Agreement to prevent future termination with no money down, no late fees or penalties
- 8. The Town will file a final report detailing the number of affected households using PSL Amendment protections, the number of Deferred Payment Agreements for the period May 24, 2011 to December 31, 2021 and the number of disconnections for non-payment from May 24, 2021 to December 31, 2021, with DPS within thirty (30) days of the expiration date of the PSL and GBL Amendments of July 1, 2022.
