NOTICE REQUESTING COMMENTS

(Issued July 7, 2025)

The New York State Department of Public Service (DPS or Department) is seeking comment on PSEG Long Island's (PSEG LI) proposed Utility 2.0 Long Range Plan 2025 Annual Update (Utility 2.0 Plan). On July 1, 2025, in accordance with the Long Island Power Authority Reform Act (LRA), PSEG LI submitted the Utility 2.0 Plan to the DPS for review and recommendation. Pursuant to the LRA, the purpose of the Utility 2.0 Plan is to implement energy efficiency measures, distributed generation, or advanced grid technology programs providing customers with tools to more efficiently and effectively manage their energy usage and utility bills and improve system reliability and power quality.

The Department's review of the Utility 2.0 Plan is being conducted concurrently with its review of PSEG LI's 2025 Building Efficiency and Electrification (BEE) Plan, which was submitted as part of the Utility 2.0 Plan. Additionally, as it did last year, this year's Utility 2.0 Plan includes five-year projections through 2030 for many of the initiatives contained therein.

PLEASE TAKE NOTICE that interested persons or parties are invited to submit comments regarding the Utility 2.0 Plan and the BEE Plan by **Thursday August 21, 2025**. Reply comments are requested by **Friday September 5, 2025**.

The Utility 2.0 Plan, including the BEE Plan, may be viewed on the Department's website at www.dps.ny.gov by clicking on "File Search" (located under the heading "Commission Files"),

and entering "14-01299" in the "Search by Case Number" field. The Utility 2.0 Plan, including the BEE Plan, may also be viewed on the DPS Long Island Office website by going to <https://dps.ny.gov/dps-long-island> and selecting the Utility 2.0 tab.

Comments should be submitted electronically to the Secretary by e-filing through the Department's Document and Matter Management System. All written comments submitted to the Secretary will be posted on the Department's website and will become part of the record of the proceeding in which they are posted. Please be advised that untimely comments may not be considered by the Department.
