The principal purposes of the procedural conference are to identify the parties and major issues, discuss a schedule for these proceedings, address issues related to the service of documents and discovery, and to address any other pertinent procedural issues.

A brief technical conference will be presented by the Company's experts and will consist of an overview of the rate case filings. Following the presentation there will be a limited amount of time for the parties to ask clarifying questions so that they may better understand the scope and nature of the rate filings.
