NOTICE OF VIRTUAL PROCEDURAL AND TECHNICAL CONFERENCES

PLEASE TAKE NOTICE that a virtual procedural conference, followed by a technical conference, will be held before Administrative Law Judges James A. Costello, Tara A. Kersey, and Nicholas Planty on Tuesday, March 4, 2025, by Webex. The procedural conference will begin at 10:30 a.m. and will be followed immediately by the technical conference. These conferences concern rate requests filed on January 31, 2025, by Consolidated Edison Company of New York, Inc. (Con Edison) for electric and gas service.

The principal purposes of the procedural conference are to identify the parties and major issues, discuss a schedule for the proceedings, address issues related to the service of documents and discovery, and address any other pertinent procedural issues.

At the technical conference, Con Edison's experts will present an overview of the rate case filings and following the presentation, parties may ask clarifying questions so that they may better understand the scope and nature of the rate filings.
