ORES DMM Matter No. 24-03042 - Application of MOSS RIDGE SOLAR 1, LLC for a Major Renewable Energy Facility Siting Permit Pursuant to Article VIII of the New York State Public Service Law to Develop, Design, Construct, Operate, Maintain, and Decommission a 60-Megawatt (MW) Solar Energy Facility Located in the Town of De Kalb, St. Lawrence County.

NOTICE OF CLOSURE OF LOCAL AGENCY ACCOUNT (Issued April 9, 2025)

JOHN L. FAVREAU and CHRISTOPHER MCENENEY CHAN, Administrative Law Judges:

On September 3, 2024, Moss Ridge Solar 1, LLC (applicant), applied to the New York State Office of Renewable Energy Siting and Electric Transmission (ORES or Office) for a siting permit pursuant to Public Service Law article VIII (Article VIII) to construct and operate a 60-megawatt (MW) solar energy facility located in the Town of De Kalb, St. Lawrence County.

With the application, applicant submitted the required local agency account fee in the amount of \$60,000. The notice of application filing and availability of local agency account funding dated September 4, 2025, set forth Friday, October 4, 2024, at 4:30 p.m., as the deadline for local agencies and potential community intervenors to submit requests for local agency account funds. To date, no applications for funds have been submitted.

On April 7, 2025, applicant filed a request to withdraw the application (<u>see</u> DMM Item No. 21). As there were no applications for local agency account funding, there has not been an award issued in this matter. Accordingly, **PLEASE TAKE**NOTICE that the local agency account in this matter is hereby closed. NYSERDA is hereby directed to return any undisbursed funds to Moss Ridge Solar 1, LLC (see 16 NYCRR 1100-5.1[g][4]).
