NOTICE EXTENDING DEADLINES

(Issued June 10, 2024)

On June 23, 2023, the Public Service Commission (Commission) issued an Order Adopting Energy Broker and Energy Consultant Registration Requirements (Order) in these proceedings. Following the issuance of the Order, several petitions for rehearing and requests for extensions were filed. By notice issued August 10, 2023, the requests to extend the deadlines set forth in Ordering Clauses 2, 3, 5, 6, and 8 of the Order were granted, until such time as the Commission issued its decision in response to the petitions seeking rehearing.¹

On April 18, 2024, the Commission issued a Declaratory Ruling and Order on Rehearing (Rehearing Order) that established a deadline of June 17, 2024, for compliance with the Rehearing Order. On May 17, 2024, Family Energy, Inc. (Family) submitted a petition for rehearing, reconsideration and/or clarification of the Rehearing Order (May 17 Petition), followed by a May 28, 2024 request seeking a 90-day extension of time with respect to complying with the Rehearing Order. Family asserted that it needed to update sales agreements, train marketing

representatives, and develop internal processes; it added that the extension, if granted, would give the Commission time to consider Family's May 17 Petition.

On June 3, 2024, the New York Retail Choice Coalition (NYRCC) also submitted a request for an extension of time to comply with the deadlines set forth in the Rehearing Order. In its request, NYRCC stated its intent to commence a proceeding pursuant to Article 78 of the Civil Practice Law and Rules challenging the Commission's decisions in the Order and Rehearing Order, and asked for an extension until 60 days after a court decided the Article 78 challenge.

On June 5, 2024, IDT Energy, Inc. (IDT) submitted a letter in support of Family's May 17 Petition. IDT requested an extension of time until after the Commission takes action to fully adopt the rules and regulations that will apply to energy brokers and energy consultants.

In consideration of the foregoing, and pursuant to the authorization contained in the Rehearing Order (Ordering Clause 11), the deadlines set forth in Ordering Clauses 3, 4, 6, 7, and 9 of the Rehearing Order are extended until July 31, 2024, while the deadline set forth in Ordering Clause 8 of the Rehearing Order is extended until December 31, 2024.
