Dear Secretary Phillips:

This letter will serve as notice that Spectrum Northeast, LLC (“Spectrum”) will drop the following stations on or after April 13, 2026:

- WWTI 3 Laff and WWTI 4 ION Mystery on the Boonville channel lineup
- WIVT 3 Laff and WIVT 4 ION Mystery on the New Berlin channel lineup

Spectrum Northeast, LLC (“Spectrum”) will drop out-of-market station on or after April 27, 2026.

- WGRZ NBC Out-of-Market station on the Monroe channel lineup
Note: Programming for NBC will still be available via in-market station WCYB on channel 5

This letter will also serve as notice that Spectrum Northeast LLC (“Spectrum”) recently learned that WNJN NHK World will cease broadcasting on or around March 31, 2026. Accordingly, on or after March 31, 2026, Spectrum will drop WNJN NHK World on the New York City channel lineups. This change is out of Spectrum’s control.
