NOTICE CONCERNING LETTER OF CREDIT EXTENSION REQUESTS

(Issued July 31, 2024)

Pursuant to the June 23, 2023 Order Adopting Energy Broker and Energy Consultant Registration Requirements and the Declaratory Ruling and Order on Rehearing, issued on April 18, 2024 (April Rehearing Order), in the above-referenced proceedings, Energy Brokers and Energy Consultants are required to file completed registration packages in Matter Number 23-01227. The completed packages are required to include, among other things, a letter of credit (LOC). Pursuant to a Notice Extending Deadlines, issued on June 10, 2024, in these proceedings, the current deadline for filing such packages is July 31, 2024.

This limited extension is granted to promote the fair, orderly, and efficient conduct of these proceedings.

All requests submitted after July 29, 2024, seeking an additional extension of time to file all or part of the required registration packages are denied as untimely. All such requests submitted after July 29, 2024, are denied, even if they are not listed above.<sup>1</sup>
