## California mountain and desert towns dig out of the mud from 1st tropical storm in 84 years

CATHEDRAL CITY, Calif. (AP) — Crews in mountain and desert towns worked to clear away mud and debris Tuesday in the aftermath of the first tropical storm to hit Southern California in 84 years.

The system was dissipating as it moved over the Rocky Mountains.

Hilary dumped record rainfall over California's deserts, including in the stark Death Valley that experienced its single-rainiest day on record on Sunday.

As Hilary moved northeast into the neighboring state of Nevada, flooding was reported, power was out and a boil-water order was issued for about 400 households in the Mount Charleston area, where the only road in and out was washed out. The area is about 40 miles (64 kilometers) west of Las Vegas.

Hilary first slammed into Mexico's arid Baja California Peninsula as a hurricane, causing one death and widespread flooding before becoming a tropical storm. So far, no deaths, serious injuries or extreme damages have been reported in California, though officials warned that risks remain, especially in the mountainous regions where the wet hillsides could unleash mudslides.

In one dramatic scene, rescue officials in the desert community of Cathedral City, near Palm Springs, drove a bulldozer through mud to a swamped care home and rescued 14 residents by scooping them up and carrying them to safety, Fire Chief Michael Contreras said.

"We were able to put the patients into the scoop. It's not something that I've ever done in my 34 years as a firefighter, but disasters like this really cause us to have to look at

those means of rescue that aren't in the book and that we don't do everyday," he said at a news conference.

It was one of 46 rescues the city performed between late Sunday night and the next afternoon from mud and water standing up to 5 feet (1.5 meters).

Hilary is the latest potentially climate-related disaster to wreak havoc across the U.S., Canada and Mexico. Hawaii's island of Maui is still reeling from a blaze that killed more than 100 people, making it the deadliest U.S. wildfire in more than a century. Firefighters in Canada are battling that nation's worst fire season on record.

Hot water and hot air were both crucial factors that enabled Hilary's rapid growth — steering it on an unusual but not quite unprecedented path that dumped rain in some normally bone-dry places.

The wet weather might stave off wildfires for a few weeks in Southern California and in parts of the Sierra Nevadas, but widespread rain is not expected in the most fire-prone areas, University of California, Los Angeles, climate scientist Daniel Swain said in an online briefing Monday.

Flooding and mudslides were reported across Southern California's inland desert and mountain areas.

In the San Bernardino Mountains, crews worked to clear mud that blocked the homes of about 800 residents, Cal Fire Battalion Chief Alison Hesterly said.

Hilary shattered daily rain records in San Diego and dumped the equivalent of a full year's worth on Death Valley National Park, forcing the park to be closed indefinitely.

## Washington, Sheen shout for solidarity between Hollywood strikers, other workers

LOS ANGELES (AP) — Kerry Washington and Martin Sheen, a pair of fictional former politicians, turned Hollywood's strikes into a rousing campaign rally Tuesday with speeches celebrating unity across the industry and with labor at large.

"We are here because we know that unions matter," said Washington, who played a political fixer on ABC's "Scandal." "Not only do we have solidarity within our union, we have solidarity between our unions, because we are workers."

The rally outside Disney Studios in Burbank, California, coming more than a month into a strike by Hollywood actors and more than three months into a strike by screenwriters, was

meant to highlight their alliance with the industry's other guilds and the nation's other unions, including the Teamsters and the AFL-CIO. "The audacity of these studios to say they can't afford to pay their workers after

they make billions in profits is utterly ridiculous," Los Angeles County Federation of Labor President Yvonne Wheeler told the crowd. She added a dig at Disney's CEO, who has become a target of strikers. "But despite their money, they can't buy this kind of solidarity. Tell Bob Iger that."

Sheen, who played the president for seven seasons on "The West Wing," was joined by most of the show's main cast members on the stage as he emphasized that the toll being taken as the strikes stretch out.

"Clearly this union has found something worth fighting for, and it is very costly," Sheen said. "If this were not so we would be left to question its value."

## Rescuers save 8 people trapped in cable car dangling above canyon in Pakistan

PESHAWAR, Pakistan (AP) — Army commandos using helicopters and a makeshift chairlift rescued eight people from a broken cable car dangling hundreds of meters (feet) above a canyon Tuesday in a remote part of Pakistan, authorities said.

The six children and two adults became trapped earlier in the day when one of the cables snapped while the passengers were crossing a river canyon in Battagram district in Khyber Pakhtunkhwa province. The children had been on their way to school.

Caretaker Prime Minister Anwaar-ul-Haq Kakar congratulated the military and other rescuers for the success.

The dramatic effort transferred the country for hours as Pakistanis crowded around televisions in offices, shops, restaurants and hospitals.

"Relieved to know that ... all the kids have been successfully and safely rescued," Kakar said on X, the service formerly known as Twitter. "Great team work
