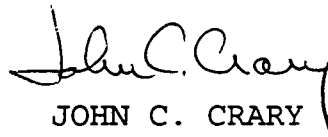
By letter dated February 10, 1997 from the Department of Public Service staff (staff) and Consolidated Edison Company of New York, Inc. (Con Edison), staff and Con Edison state that a comprehensive proposed settlement of Case 96-E-0897 is possible. Staff and Con Edison claim that additional time is needed to finalize a settlement, including time to get input from other parties. Staff and Con Edison request an extension of the February 14 date for the filing of testimony to February 21, and the granting of authority to the presiding administrative law judge to extend the filing schedule to February 28, if needed.

Several parties, including Enron Capital & Trade Resources, Multiple Intervenors, and the New York Energy Buyers Forum, oppose the requested extension of time. The parties claim, among other things, that there is no persuasive reason for

any further delay of the filing of testimony, particularly after the Commission's recent notice which stated that the February 14 filing date "remains unchanged in all cases."¹ The parties also point to a potential inequity if parties' testimony is still filed in other individual utility dockets on February 14, but not in the Con Edison docket. Further, the parties suggest that settlement negotiations could continue after the filing of testimony.

The Commission previously expressed its strong interest in seeing negotiated resolutions of the issues raised in these proceedings.² Under these circumstances, Chairman John F. O'Mara has determined that an additional two weeks for the filing of either a settlement or testimony is reasonable in all five cases. Accordingly, for all five dockets, either a settlement agreement or initial testimony must be filed with the Commission and served in-hand on the presiding administrative law judges and all parties no later than February 28, 1997.
