NOTICE REQUESTING COMMENTS AND ANNOUNCING
PUBLIC STATEMENT HEARING AND PROCEDURAL CONFERENCE

(Issued September 4, 2025)

Comments are requested concerning a petition filed by Riverside Solar, LLC (the Petitioner) seeking lightened regulation as a wholesale electric generator and a Certificate of Public Convenience and Necessity under Section 68 of the Public Service Law. The Petitioner seeks authorization to construct and operate an up to 100-megawatt photovoltaic solar energy generation facility in the towns of Lyme and Brownville in Jefferson County, New York (the Facility).

Construction and operation of the Facility would be subject to the terms and conditions of the Siting Permit that was issued by the Office of Renewable Energy Siting (ORES) on January 9, 2023. The scope of the Public Service Commission's (Commission) review of the petition will not duplicate the issues that were previously considered and decided by ORES.

Those wishing to comment on any aspect of this proceeding will have the opportunity to make a statement on the record at the virtual public statement hearing.

To participate electronically:

This option is for participants who would like to make a statement and who will log in to the hearing electronically. Such participants may log in at the date and time indicated above by visiting **meetny-gov.webex.com** and entering the event number and password listed above.

When logging in on the date and time of the hearing, participants will be asked to "select audio system." It is recommended that participants opt to have the system "call me" or "call using computer." The "call me" option will require that participants enter their phone numbers.

To participate by phone:

This option is for participants who would like to make a statement but who will not be logging into the hearing electronically. On the date and time of the hearing, call-in participants should dial **1-929-251-9612** and enter the applicable access code and phone-in password listed above.

To listen to the hearing without making a statement:

Any interested person may listen to the hearing by phone by calling **1-929-251-9612** and entering the access code and phone-in password listed above.

All participants will be muted upon entry into the hearing. The ALJ will call upon each person who asks to make a statement. The ALJ will continue the hearing until everyone wishing to speak has been heard or other reasonable arrangements to submit comments into the record have been made. Reasonable

time limits may be set for each speaker as necessary to afford all attendees an opportunity to be heard. It is recommended that lengthy comments be submitted in writing and summarized for oral presentation. A verbatim transcript of the hearing will be made for inclusion in the record of this case.

Comments submitted in accordance with this Notice will be posted on the Department's website and may be accessed by searching the case number, as described above, and clicking on the "Public Comments" tab.

PLEASE TAKE FURTHER NOTICE that a virtual procedural conference will be held immediately following the public statement hearing, as part of the same teleconference.

The principal purposes of the procedural conference are to identify any potential parties and provide interested persons an opportunity to present and explain any proposals regarding the procedures they believe should be followed in this case by the ALJ and Commission including, but not limited to, whether any issues of fact presented by the petition or public comments warrant an evidentiary hearing. Other procedural issues also may be addressed.
