Question:

On page 62 of the Staff Gas Safety Panel's testimony, the Panel indicates that it is generally supportive of incremental gas safety positions, including positions related to engineering development, but recommends approval of only 34.5 of the remaining 69 incremental FTE positions that the Companies requested. The 69 remaining FTE positions include two engineers in development positions. The Companies filled two engineers in development positions in June 2022 as part of the approved 2020 Joint Proposal.

Does Staff agree that these 2 positions should not be subject to Staff's 50% reduction of the remaining 69 incremental FTEs?

Response:

No. On page 38 of Rochester Gas and Electric Corporation's (RG&E's) Gas and Hydro Engineering and Operations Panel's direct testimony, it states that "Gas Engineering is requesting two additional Engineers for its Development Program." This implies that RG&E is requesting two engineers in addition to the two engineers approved as part of the approved 2020 Joint Proposal. Thus, the Staff Gas Safety Panel's 50% reduction would apply to the two incremental engineer development positions.

Question:

On page 62 of the Staff Gas Safety Panel's ("SGSP") testimony, the Panel recommends approval of only 34.5 of the remaining 69 incremental FTE positions that the Companies requested. The 69 remaining FTE positions include one Hydro Operations positions at RG&E and four Hydro Engineering position at NYSEG, with two of the positions being backfills of open positions (see NYSEG Gas and Hydro Engineering and Operations Panel testimony at page 59).

Does Staff agree that these 5 positions should not be subject to Staff's 50% reduction of the remaining 69 incremental FTEs?

Response:

Yes. The five incremental hydro operations positions should not be subject to the Staff Gas Safety Panel's 50% reduction.
