Please accept this letter and accompanying supporting data as our formal application for Tier 2 Maintenance Resource Support for the Hydro Development Group Acquisition, LLC, Hailesboro 6 hydroelectric generating facility (“Hailesboro 6”) owned and operated by Patriot Hydro Funding, LLC since December 22, 2022. Hailesboro 6 has faced higher operation and maintenance (“O&M”) costs and prolonged outages due to: (i) the repair of Unit 1, representing 50% of the plant’s capacity, from July 2022 through January 2024 due to a gearbox failure; (ii) replacement of the Gang-Operated Air Break (“GOAB”) switch due to age and deterioration; (iii) replacement of the station service disconnect switch due to significant degradation; (iv) disassembly and repair of the Unit 2 gearbox in early 2025 following an oil leak and bearing failure; and (v) required upgrades to the facility’s protective relaying and telemetry systems to ensure compliance with National Grid and NYISO interconnection requirements. The facility’s financial performance has also been adversely affected due to the significant decline in Renewable Energy Credit (“REC”) prices under New York’s Voluntary Hydropower

Environmental Disclosure Program (“EDP”), which have fallen from approximately \$25 per megawatt-hour (“MWh”) in late 2023 to \$3 per MWh in 2025.

This submission and its attachments (the “Application”) are constructed in accordance with the procedures published on the New York State Public Service Commission (“NYSPSC”) website and include the following:

1. Completed Maintenance Tier Application Spreadsheet Workbook from the NYSPSC.
 - a. The Hailesboro 6 Maintenance Tier Application Spreadsheet Workbook is included and contains required facility and financial information.

2. Financial statements provided for years post-acquisition:
 - a. Balance sheets – Data included in the Financial Statements Workbook and supported by Patriot Hydro Funding, LLC’s audited financial statements (2023, 2024).
 - b. Cash flow statements – Data is included in the Financial Statements Workbook and supported by Patriot Hydro Funding, LLC’s audited financial statements (2023, 2024).
 - c. Income tax returns – Entity disregarded for tax purposes, information related to taxes included in the School and Town/County Tax Statements (2023-2025).

3. Facility identification and operating information:
 - a. Type of facility – Data is included in the Application Spreadsheet Workbook.

Hailesboro 6 is a hydroelectric generation facility rated at 0.90 MW (nameplate) with an unforced capacity (“UCAP”) rating of 0.40 MW for both summer and winter. The facility is classified as Hydro (10 MW or less) and operates as a run-of-river plant. The Hailesboro 6 facility sells its output to National Grid under a power purchase agreement (“PPA”).

- b. Location – Data is included in the Workbook. The Hailesboro 6 facility is located in Hailesboro, New York, within the Mohawk Valley region (NYISO Load Zone E).
 - c. Date of commercial operation – Data is included in the Application Spreadsheet Workbook. The Hailesboro 6 facility commenced commercial operation in 1983.
 - d. List of Affiliates – Data is included in the Application Spreadsheet Workbook. The Hailesboro 6 facility is a subsidiary of Patriot Hydro Funding, LLC which collectively owns, directly manages, and operates a fleet of thirty-nine (39) hydroelectric facilities across the United States. Patriot Hydro Funding, LLC is wholly owned by Patriot Hydro, LLC, which has an ultimate parent in LS Power Development, LLC.
 - e. List of Contracts – Data is included in the Application Spreadsheet Workbook. The Hailesboro 6 facility sells its output to National Grid under an interim energy sale agreement which, subject to renegotiation, will expire on 4/30/2026, at the Service Classification No. 6 tariff rate.
 - f. Description of financing arrangements – Data are included in the Application Spreadsheet Workbook and supported by the Patriot Hydro Funding, LLC audited financial statements. The Hailesboro 6 facility is financed as part of Patriot Hydro Funding, LLC’s portfolio-level credit structure.
4. Additional information:
- a. The expense and balance sheet data are taken from the attached Financial Statements Workbook and Patriot Hydro Funding, LLC’s audited financial statements. The Hailesboro 6 facility qualifies under the Clean Energy Standard and Appendix D, as clarified by the Commission’s March 16, 2018 Order Adopting Measures for the Retention of Existing Renewable Baseline Resources (Case 15-E-0302). Hailesboro 6 is not receiving Tier 1 REC support. Historical revenues were used in the

Application as required, and Maintenance Tier 2 price support is requested at \$70.96 per MWh for 10 years.

Patriot Hydro Funding, LLC has separately filed with the Records Access Officer non-redacted versions of the aforementioned documents alongside a request for Confidentiality pursuant to Public Officers Law §§87(2)(d) and 89(5)(a)(1) and the Commission's implementing regulations at 16 NYCRR §6-1.3, including:

4. Audited consolidated financials report and roll-up (2023, 2024)
