

Pursuant to Certificate Condition 1 of Appendix D of the Joint Proposal approved in Ordering Paragraph 1 of the February 12, 2026 Order Adopting Terms of a Joint Proposal ("Order") of the Public Service Commission in the above-captioned proceeding, Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid") provides this verified statement that it accepts and will comply with the Certificate of Environmental Compatibility and Public Need granted in the Order. This verification was inadvertently not uploaded with National Grid's Request for Limited Notice to Proceed of the Maiden Lane Substation in February 2026. National Grid has complied with Certificate of Environmental Compatibility and Public Need while implementing the Maiden Lane Substation EM&CP, which was approved by the Public Service Commission on February 17, 2026.


