EXHIBIT 1 GENERAL REQUIREMENTS

(a) PROJECT DESCRIPTION

The proposed Facility is a utility-scale wind energy generating project located in Cayuga County, New York with a generating capacity of up to 99 megawatts (MW). The Facility will include up to 24 wind turbines and associated support facilities, including a medium voltage collection system, gravel access roads, two permanent meteorological (MET) towers, an aircraft detection lighting system (ADLS) tower, temporary construction laydown areas, a temporary concrete batch plant, an operations and maintenance (O&M) facility, a medium voltage-to-transmission voltage collection substation, a point of interconnection (POI) switchyard, and a short 115kV overhead transmission line that will connect the Facility to the high voltage electrical grid.

(b) Applicant Information

Agricola Wind LLC (Agricola Wind or the Applicant) is a wholly owned subsidiary of Liberty Renewables Inc. (Liberty Renewables) that was formed for the purposes of permitting the Agricola Wind Project. Liberty Renewables is a renewable energy company based in Albany, NY whose mission is to build, own, and operate wind energy projects throughout New York State. Liberty Renewables is owned by Copenhagen Infrastructure Partners (CIP). CIP is a global leader in renewable energy investments and makes significant and meaningful contributions to the green transition through developing, constructing, and operating greenfield renewable energy infrastructure projects, including both onshore and offshore wind projects.
