DMM Matter Number 21-00024 – Application of Riverhead Solar 2 for a Permit for a Major Renewable Energy Facility pursuant to Section 94-c of the New York State Executive Law to Construct a 36 MW Solar Energy Project located in the Town of Riverhead, Suffolk County.

NOTICE OF APPLICATION FILING AND
AVAILABILITY OF LOCAL AGENCY ACCOUNT FUNDING

(Issued January 8, 2021)

On January 8, 2021, Riverhead Solar 2, LLC filed an application seeking a permit to build and operate the Riverhead Solar 2 project (the Facility), a solar electric generating facility in the Town of Riverhead, Suffolk County, New York. The proposed Facility will have a total generating capacity of up to 36 megawatts (MW). The Facility will include solar panels, access roads, inverters, transformers, electrical collection lines, gen-tie line, and temporary construction staging, and storage areas. The Facility will interconnect to the existing point of interconnection at the Edwards Avenue substation, additional equipment will be added to the collection substation to support the interconnection of the Facility.

With its application, Riverhead Solar 2 submitted the required local agency account fee of \$36,000. Please take notice that funds are available to eligible local agencies and potential community intervenors for use in contributing to the development of a complete record leading to an informed decision by the Office of Renewable Energy Siting (ORES) as to its compliance with applicable local laws and regulations.

Local agencies and potential community intervenors intending to request local agency account funding must submit their request for funding by no later than **4:30 p.m. EST on February 8, 2021**. Parties requesting such funding must use the **ORES Request For Local Agency Account Funding** form available in the Resources section of the ORES website (www.ores.ny.gov/resources). All requests for local agency account funding must be submitted to ORES (general@ores.ny.gov).

Persons without e-mail access may mail their documents to the Office of Renewable Energy Siting (ORES), Empire State Plaza, Swan Street Building – Core 1, Room # 110-119, Albany, NY 12239, such that the requests are received by **February 8, 2021**.
