RESPONSE OF ORANGE AND ROCKLAND UTILITIES, INC. TO ORDERING PARAGRAPHS ONE THROUGH NINE OF JUNE 27, 2014 ORDER

INTRODUCTION

On June 27, 2014, the Public Service Commission ("Commission") issued an *Order Instituting the Practices and Obtaining Information Concerning Plastic Fusions on Natural Gas Facilities* ("Order"). Ordering Paragraphs one through nine of the Order direct Orange and Rockland Utilities, Inc. ("Orange and Rockland" or "the Company") to provide within five days¹ specified information regarding the extent to which LDCs in New York State have complied with the qualification and requalification requirements found in 16 NYCRR §§255.285, 255.303, 255.603(b) and 255.604. Orange and Rockland is providing the required information in this response.

As set forth below, the Company is currently in compliance with the Commission's qualification and requalification requirements. As discussed in detail below, Orange and Rockland is confident in the integrity of the plastic piping installed in our gas distribution system. In addition, Orange and Rockland is confident that the prior lapses in installer qualification did not compromise the integrity of our gas system and that all plastic pipes placed in service have been fused and tested according to acceptable procedures and specifications. The Company is

tightening its internal processes and implementing additional controls in its tracking and scheduling systems in order to comply with the Commission's requirements.

Orange and Rockland recognizes its responsibility and the importance of conforming to the Commission's safety regulations, including installer qualification. The information provided below in response to the Order demonstrates that the Company is taking appropriate steps to conform to the Commission's qualification requirements for ongoing fusion work.

RESPONSES TO ORDERING PARAGRAPHS ONE THROUGH NINE OF JUNE 27, 2014 ORDER

Response to Ordering Paragraphs 1, 2, 3 and 9

- 1. Orange and Rockland shall certify to the Department of Public Service, as soon as practicable, but by no later than within five days of the date of this order, that it has in place procedures to qualify and requalify its employees and contractors who perform fusions on plastic gas facilities in compliance with 16 NYCRR §§255.285, 255.303, 255.603(b) and 255.604.
- 2. Orange and Rockland shall certify to the Department of Public Service, as soon as practicable, but by no later than within five days of the date of this order, that its testing procedures satisfactorily conform to the program it has submitted, in accordance with 16 NYCRR §255.603(d).
- 3. Orange and Rockland shall certify to the Department of Public Service, as soon as practicable, but by no later than within five days of the date of this order, that its company procedures and testing that are administered to qualify and requalify employees and contractors who perform fusions on plastic gas pipe are in compliance with 16 NYCRR §255.285 and, by extension, 16 NYCRR §285.283(a).
- 9. Orange and Rockland shall certify to the Department of Public Service, within five days of the issuance of this order, what procedures it has in place to ensure compliance with all gas safety regulations and, in particular, what controls and procedures it used in preparing its 2014 Chief Executive Officer's Certification, required by Public Service Law §65(15).

The certifications requested by Ordering Paragraphs 1, 2, 3 and 9 are provided in Appendix A to this Response. The Company would note regarding the certification required by Ordering Paragraph 9, that in the Company's 2014 Certification, as directed by the Secretary of the Commission, Orange and Rockland's Chief Executive Officer certified to his knowledge, based on reasonable due diligence conducted by the Company, that the Company has internal controls, policies and procedures designed to ensure material compliance with the requirements of the Public Service Law, including the obligation to provide safe and adequate service, and any rules, regulations, orders and procedures adopted thereto, all of which were issued and effective on or before January 1, 2014.

The due diligence process that Orange and Rockland, in a combined effort with

Consolidated Edison Company of New York, Inc. ("Con Edison") (Orange and Rockland and

Con Edison are referred to jointly as the "Companies"), developed and executed within the

eleven-month period between the promulgation of Public Service Law §65(15) and submission

of the 2014 certification, involved the identification of applicable Public Service Law and

Commission requirements and the Companies' corresponding controls, policies and procedures

designed to ensure material compliance therewith. The first step in this process was to hire

outside counsel—individually, and also jointly with the other combination gas and electric

utilities subject to the same certification requirement—to identify the universe of applicable

Public Service Law and Commission requirements. Simultaneously, a team composed of

approximately 100 members of the various departments in both Companies, identified applicable

Public Service Law and Commission requirements known to employees of the Companies. This

combined effort identified approximately 5,000 requirements applicable to each of the

determine the department(s) responsible for compliance with each of the identified requirements. Working systematically, employee team members, in conjunction with subject matter experts within their respective departments, then reviewed all of the identified requirements applicable to their departments and identified, inventoried and linked each of those requirements to the Companies' controls, policies, and procedures.

Weekly team meetings were held with all departments to develop consistent processes for conducting their reviews and inventories and to facilitate open communication in an effort to verify that controls, policies and procedures were in place to address all identified requirements. Senior managers and officers of the Companies provided oversight of the review processes conducted within their respective departments.

While the 2014 Certification, based on the process leading up to its submission, spoke to the existence of controls, policies and procedures designed to ensure material compliance with the identified requirements, it did not, and reasonably could not, guarantee the perfect, error-free capture, interpretation and execution of each of the thousands of requirements and their constituent components.

The Companies worked with the other combination gas and electric utilities in the State to develop and implement consistent processes to comply with the certification requirement and to develop uniform language for the certifications used by each utility. Representatives from the Companies and the other certifying utilities participated in meetings to review these processes and the certification language with representatives from the General Counsel's Office of the New York State Department of Public Service.

Orange and Rockland also would note that it has between 250-300 procedures and standards, a Gas Supervisor's Operating Manual, a Gas Emergency Response Plan, and a Northeast Gas Association Operator Qualification Compliance Program, all of which assist the Company in complying with the Commission's gas safety regulations (i.e., 16 NYCRR §§255.285, 255.303, 255.603 and 255.603).

Response to Ordering Paragraph 4

4. Orange and Rockland shall, upon learning that any of its plastic fusion procedures are out of compliance with 16 NYCRR Part 255, stop work on all plastic fusions immediately, except emergency repairs, and report such stoppage to Staff immediately. The stop work order shall remain in effect until a certification is filed that a sufficient number of employees and contractors are qualified to begin work in compliance with 16 NYCRR Part 255.

Orange and Rockland has performed a review of its plastic fusion procedures and found that they are compliant with 16 NYCRR Part 255.

Response to Ordering Paragraph 5

5. Orange and Rockland shall identify and provide to the Department of Public Service, within five days of the date of this order, a list of any persons whose qualifications or re-qualifications are found to be out of compliance with procedures for performing plastic fusions, in particular, 16 NYCRR §§255.285, 255.303, 255.603, and 255.604.

Orange and Rockland has performed a review and found that all employees and contractors that perform fusions on gas plastic pipe facilities currently are compliant with procedures for performing plastic fusions, in particular, 16 NYCRR §§255.285, 255.303, 255.603, and 255.604.

Response to Ordering Paragraph 6

6. Orange and Rockland shall, within five days of the date of this order, provide to the Department of Public Service a list that includes, if applicable, the date and duration of time for each person whose qualifications or re-qualifications were not in compliance with 16 NYCRR §\$255.285, 255.303, 255.603(b) and 255.604 at any time since 16 NYCRR §255.604 went into effect.

As noted in its response to Ordering Paragraph 5 above, in conducting a review of its plastic fusion training procedures, Orange and Rockland has determined that all employees and contractors that perform fusions on gas plastic pipe facilities currently are compliant with procedures for performing plastic fusions. Orange and Rockland has determined, however, that certain individuals had overdue qualifications at times during the past five years. A list of those individuals is set forth in Appendix B to this response. Orange and Rockland is reviewing its records to determine if these individuals were in fact out of compliance by performing fusion tasks while their qualifications were overdue. Orange and Rockland has limited its response to a five-year time frame since 16 NYCRR §255.604(b) only requires Orange and Rockland to maintain qualification records for five years.

Response to Ordering Paragraph 7

7. Orange and Rockland shall each identify to the Department of Public Service, within five days of the date of this order, any persons found to have been out of compliance with 16 NYCRR §§255.285, 255.303, 255.603(b) and 255.604 or each company's own procedures at any time since 16 NYCRR §255.604 was effective, and the number and location of plastic fusions performed in the LDC's service territory by each such person.

As noted in its response to Ordering Paragraph 6 above, Orange and Rockland has determined that certain individuals had overdue qualifications at times during; the past five years.

Orange and Rockland is reviewing its records to determine if these individuals were in fact out of compliance by performing fusion tasks while their qualifications were overdue. Orange and Rockland also has commenced its effort to identify, pursuant to this Ordering Paragraph 7, the number and location of any plastic fusions performed by such individuals. It will take Orange and Rockland some time to review all the necessary documents in order to complete this identification process. Accordingly, on July 3, 2014, the Company submitted a request to Secretary Burgess for an additional 20 business days to comply with this Ordering Paragraph 7. By ruling dated July 7, 2014, Secretary Burgess granted Orange and Rockland an extension until July 28, 2014. Orange and Rockland will work closely and communicate regularly with Staff regarding its efforts to comply with this Ordering Paragraph 7. If Orange and Rockland is able to submit its response to Ordering Paragraph 7 prior to July 28, 2014, it will do so.

Response to Ordering Paragraph 8

8. Orange and Rockland shall, within five days of the date of this order, in identifying whether locations exist where employees or contractors completed plastic fusions and were not qualified or re-qualified to have done so, identify how the company will address any safety risk posed by work done by such employee or contractor.

Orange and Rockland has long sought to maintain the integrity of its plastic gas mains and services through a multifaceted, quality control approach that encompasses the purchase, installation, testing and performance tracking of piping and components installed on the system, as well as installer training and qualification. The following paragraphs on plastic materials, training, visual inspection, pressure testing, and leakage tracking describe this approach.

Plastic Materials

The Company specifies that piping, fittings, and other system components are to be made from high quality plastic materials by select manufacturers. This provides consistency in material quality that enhances the repeatability of high quality fusion joints during installation.

Training

Orange and Rockland's installers are provided the knowledge and training necessary to properly join plastic pipe. Every fusion joint made on the Orange and Rockland system is constructed by an installer who has been thoroughly trained in fusing techniques. Orange and Rockland's installers are trained to follow detailed instructions for the installation of plastic fusion joints that incorporate and build upon the procedures developed by manufacturers and industry groups. These instructions contain separate step-by-step fusion instruction modules for different pieces of approved fusion equipment. Orange and Rockland's procedures, based on manufacturer recommendations, identify and prescribe acceptable criteria for all of the essential elements that must be controlled in order to perform acceptable fusion joints. Orange and Rockland's Training Department has developed written materials and practical applications, including written testing and hands-on testing, to effectively teach and train employees and contractors to perform fusing using these fusing procedures. The hands-on testing requires each student to demonstrate understanding of the procedures and ability to produce a fusion joint of acceptable quality.

Visual Inspection

The Company's installers are trained to differentiate visually between acceptable and unacceptable fusions. Orange and Rockland's written fusing procedure requires that the installer visually inspect the entire circumference of the fusion joint for the visual criteria of a good quality fusion joint. An installer's experience in repeatedly making joint fusions reinforces

expertise in assessing the quality of a fusion joint. The use of a visual quality inspection is the current industry standard method for evaluating the quality of field fusion joints. It also satisfies the field fusion inspection code requirements (i.e., see, 16 NYCRR §255.285 (b), "The specimen joint must be visually examined during and after assembly or joining and found to have the same appearance as a joint or photographs of a joint that is acceptable under the procedure.").

Pressure Testing

Pressure testing of mains and services is performed after the installers have completed fusing work and prior to customer turn-on. These pressure tests provide objective verification that mains and services are leak free by subjecting them to pressures higher than they will experience in normal service. Test pressures range from 1.5 times the maximum allowable operating pressure ("MAOP"), in the case of high pressure mains, to several hundred times the MAOP, in the case of low pressure mains and services. As an example, for the low pressure system, where typical operating pressures are 0.25 psig, a 90 psig pressure test is performed. This is 360 times the normal operating pressure of the system. For some short exposed sections and tie-in sections, mains or services are soap bubble tested at line pressure to provide assurance that they are leak free. This testing method is in compliance with 16 NYCRR 255.507(f) and Orange and Rockland's Work Procedures.

CONCLUSION

Orange and Rockland recognizes its responsibility and the importance of conforming to the Commission's safety regulations including installer qualification. Orange and Rockland is confident in the integrity of the plastic piping installed in our gas distribution system. Orange and Rockland is confident that the prior lapses in installer qualification did not compromise the integrity of the gas system and that all plastic pipes placed in service have been fused and tested according to acceptable procedures and specifications.
