NOTICE OF VIRTUAL PROCEDURAL AND TECHNICAL CONFERENCES

**PLEASE TAKE NOTICE** that a virtual procedural conference, followed by a technical conference, will be held before Administrative Law Judges Tara A. Kersey and Ashley Moreno on Thursday, July 17, 2025, by Webex. The procedural conference will begin at 10:30 a.m. and will be followed immediately by the technical conference. These conferences concern rate requests filed on June 30, 2025, by New York State Electric & Gas Corporation (NYSEG) and Rochester Gas and Electric Corporation (RG&E) for electric and gas service.

The principal purposes of the procedural conference are to identify the parties and major issues, discuss a schedule for the proceedings, address issues related to the service of

documents and discovery, and address any other pertinent procedural issues.

At the technical conference, NYSEG and RG&E's experts will present an overview of the rate case filings and following the presentation, parties may ask clarifying questions so that they may better understand the scope and nature of the rate filings.
