TO ALL LANDOWNERS OF LAND ON WHICH ANY PORTION OF THE FACILITY PROPOSED IN NATIONAL GRID'S PUBLIC SERVICE LAW ARTICLE VII CERTIFICATE APPLICATION TO THE PUBLIC SERVICE COMMISSION IS TO BE LOCATED:

Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid") is building a smarter, stronger, cleaner energy grid to deliver a more robust, resilient, and secure energy network for our customers and communities. Our work includes upgrading the local transmission grid in Jefferson, Oswego, and Onondaga Counties to improve resiliency and reliability, and connect clean energy produced right here in New York. These initiatives will improve your service and benefit the local economy by bringing new construction jobs and associated spending to your community.

National Grid intends to file an application (the "Application") on or about March 14, 2025 with the New York State Public Service Commission ("PSC") pursuant to Public Service Law Article VII requesting a Certificate of Environmental Compatibility and Public Need to allow National Grid to construct and operate its proposed Black River - Clay 115 kV Transmission Rebuild Project in Jefferson, Oswego, and Onondaga counties, New York ("Project").

The proposed National Grid Project consists of approximately 60.9 miles of transmission line rebuild running between the Black River Substation in the Town of LeRay, Jefferson County and the Clay Substation in the Town of Clay, Onondaga County. National Grid will be replacing the existing double circuit Black River – Lighthouse Hill Line and the bussed Lighthouse Hill – Clay Line with two new single circuit lines constructed 25-35 feet (ft) on either side of the existing transmission line centerline. The right-of-way (ROW) for the new lines will extend an additional 50 ft beyond the new single circuit lines. Therefore, the new ROW will be approximately 170-ft-wide, which will serve as the limits of the Project Area. The Project is essentially viewed as two sections: the double circuit Black River – Light House Hill ("LHH") section (35.9 miles) and the bussed LHH – Clay section (25 miles). Both sections will be rebuilt as two single circuit facilities. The Project also includes the expansion of the existing Staplin Creek Substation beyond the existing fence line and the Applicant's property. The substation expansion involves converting a 6-breaker ring and converting all existing disconnects at the station with new 3000A Units.

Your property may be impacted by this Project.

After the Application has been filed and the PSC has assigned it a case number, interested persons who wish to participate as parties in this case may file a notice of intent to be a party in the case. This may be done through the PSC's web site. From the home page of the PSC's web site

(<http://www.dps.ny.gov>), a prospective party should click on “Search”. Under “Popular Searches”, select “Latest Cases/Matters started”. In the “Search” section on the right side of the web page that appears, enter “Black River to Clay Line”. Then, in the “Search Results” at the bottom of the page, click on the Case/Matter number on the left side. This will bring the user to the main Document and Matter Management (DMM) page for this case. On that page, the prospective party should click the button at the upper right labeled “Request for Party Status” to see a web page with instructions for the procedures to follow to become a party. The timeframe for filing a request to be a party to this case is throughout the pendency of the case.

Ways to Comment to the Commission:

Via the Internet or Mail: The public may submit comments by email to the Hon. Michelle L. Phillips, Secretary, at secretary@dps.ny.gov or by mail to Secretary Phillips at the New York State Public Service Commission, Three Empire State Plaza, Albany, New York 12223-1350. Comments may also be entered directly into the case file for this matter by clicking on the button at the upper right labeled “Post Comments” on the main DMM page for this case (see above).

Via the Commission’s Toll-Free Opinion Line: Individuals may choose to submit comments by calling the Commission’s Opinion Line at 1-800-335-2120. This line is set up to receive in-state calls 24 hours a day. These calls are not transcribed but a summary is provided to the Administrative Law Judge who will report to the Commission.

All comments should refer to the case number. All comments will become part of the record considered by the Commission. Comments will be accepted throughout the pendency of this case. Also on the main DMM page for this case (see above), one can click on the “Public Comments” tab to read written comments, and on the “Filed Documents” tab to see other documents such as the application and transcripts of public statement hearings. Our work, taking place in neighborhoods like yours across Upstate New York, is called the **Upstate Upgrade**. It involves more than 70 projects through 2030 that will transform the transmission grid to meet growing demand for electricity while generating thousands of new jobs and more than \$1 billion in economic growth across the region.

On or about March 14, 2025, National Grid plans to begin the permitting process for our Black River-Clay 115kV Transmission Rebuild Project located in Onondaga, Oswego, and Jefferson counties. Below and attached you will find information on the project and the permitting process.

What is the Black River-Clay 115kV Transmission Rebuild Project?

This project is an approximately 60.9-mile, 115kV electric transmission line rebuild that will include the construction of a new substation in Jefferson County, NY. The upgrade will replace aging infrastructure and improve reliability and resiliency while creating jobs and other regional economic benefits. The project is estimated to begin construction in spring 2026.

What is the permitting process?

The initiative is being permitted under Article VII of the New York State Public Service Law. The Article VII permitting process begins with an application to the New York Public Service Commission for a Certificate of Environmental Compatibility and Public Need. Next, the PSC hosts a public statement hearing to gather feedback from interested parties. If the Certificate of Environmental Compatibility and Public Need is granted by the PSC, we will then submit an Environmental Management and Construction Plan for PSC approval. The Environmental Management and Construction Plan provides details for project construction. Information on the Article VII process can be found on our website,

How can I participate in the process?


Our work, taking place in neighborhoods like yours across Upstate New York, is called the **Upstate Upgrade**. It involves more than 70 projects through 2030 that will transform the transmission grid to meet growing demand for electricity while generating thousands of new jobs and more than \$1 billion in economic growth across the region.

In Onondaga, Oswego, and Jefferson counties, this work includes rebuilding transmission lines, totaling approximately 60.9 miles. The project is located in the towns of Clay, Cicero, Hastings, Parish, Albion, Orwell, Boylston, Lorraine, Worth, Rodman, Rutland, LeRay, and the Village of Central Square. The electric voltage and length of the project requires an Article VII Certificate issued by the New York State Public Service Commission.

Project Description

The Black River-Clay 115kV Transmission Rebuild Project will rebuild existing 115kV transmission lines and will include the construction of the new Staplin Creek Substation in Rutland. The existing double circuit 115kV transmission lines will be replaced as two single-circuit lines to improve reliability. The new lines will be placed on new galvanized steel structures and will operate at 115kV, the current voltage. When it becomes available, we will share more information about the design, including images of the proposed work, on the project website.

Proposed Project Schedule




Permitting Overview
