CASE 24-E-0415 - In the Matter of Timely Interconnection of Distributed Energy Resources.

NOTICE SOLICITING COMMENTS

(Issued July 16, 2024)

On April 20, 2024, Governor Hochul signed into law the Renewable Action through Project Interconnection and Deployment Act (RAPID Act). Among other things, the RAPID Act requires the Public Service Commission to commence a proceeding to review the cause and extent of any delays to interconnecting distributed energy resources (DERs), metrics related to timely interconnection, and potential revenue adjustments associated with such metrics. Case 24-E-0415 has been established for this purpose.

As an initial step in this proceeding, Department of Public Service staff (Staff) has prepared a set of questions to help it assess whether electric utilities and interconnection applicants are complying with the time limitations established in the Standardized Interconnection Requirements (SIRs).² Staff's questions are attached to this Notice. After Staff reviews the comments that are filed in response to the attached

Please respond to the following Staff questions by October 7, 2024:

- 1. Staff proposes to examine interconnection data for the last 5 years (2019-2024). Should a different period be selected for review?
- 2. The SIRs contain several time limits applicable to the utility's role in the process (see footnote 2 of the Notice). Which of the time limits in the current SIRs should be used to assess interconnection timeliness?
- 3. The SIRs also contain time limits applicable to the interconnection applicant's role in the process (see footnote 2 of the Notice). Which of these time limits should be assessed to evaluate interconnection timeliness?
- 4. What data sets should be used to assess whether utilities are meeting the time limits identified in the SIRs?
- 5. What data sets should be used to assess whether interconnection applicants are meeting time limits applicable to them in the SIRs?
